

House Bill 371

A BILL TO BE ENTITLED
AN ACT

1 To authorize the City of Flowery Branch to exercise all redevelopment and other powers
2 under Article IX, Section II, Paragraph VII of the Constitution and Chapter 44 of Title 36 of
3 the O.C.G.A., the "Redevelopment Powers Law," as amended; to provide for a referendum;
4 to provide effective dates; to provide for automatic repeal under certain circumstances; to
5 repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 The City of Flowery Branch shall be and is authorized to exercise all redevelopment and
9 other powers under Chapter 44 of Title 36 of the O.C.G.A., the "Redevelopment Powers
10 Law," as amended. The intention of this Act is to authorize the City of Flowery Branch to
11 undertake and carry out community redevelopment, to create tax allocation districts, to issue
12 tax allocation bonds, and to incur other obligations within the meaning of and as fully
13 permitted under the provisions of Article IX, Section II, Paragraph VII of the Constitution
14 of the State of Georgia of 1983, as amended, and to authorize the City of Flowery Branch to
15 exercise redevelopment powers as fully as the "Redevelopment Powers Law" may now or
16 hereafter permit and not to limit any redevelopment powers permitted under the
17 "Redevelopment Powers Law."

18 **SECTION 2.**

19 Unless prohibited by the federal Voting Rights Act of 1965, as amended, the election
20 superintendent of the City of Flowery Branch shall call and conduct an election as provided
21 in this section for the purpose of submitting this Act to the electors of the City of Flowery
22 Branch for approval or rejection. The election superintendent shall conduct that election on
23 a date during 2007, as determined by the governing authority and as provided under Code
24 Section 21-2-540 of the O.C.G.A., and shall issue the call and conduct that election as
25 provided by general law. The election superintendent shall cause the date and purpose of the

1 election to be published once a week for two weeks immediately preceding the date thereof
2 in the official organ of the City of Flowery Branch. The ballot shall have written or printed
3 thereon the words:

4 " YES Shall the Act be approved which authorizes the City of Flowery Branch to
5 exercise redevelopment powers under the 'Redevelopment Powers Law,' as
6 NO it may be amended from time to time?"

7 All persons desiring to vote for approval of the Act shall vote "Yes," and all persons desiring
8 to vote for rejection of the Act shall vote "No." If more than one-half of the votes cast on
9 such question are for approval of the Act, then Section 1 of this Act shall become of full
10 force and effect immediately. If Section 1 of this Act is not so approved or if the election is
11 not conducted as provided in this section, Section 1 of this Act shall not become effective
12 and this Act shall be automatically repealed on the first day of January, 2008. The expense
13 of such election shall be borne by the City of Flowery Branch. It shall be the municipal
14 election superintendent's duty to certify the result thereof to the Secretary of State.

15 **SECTION 3.**

16 Except as otherwise provided in Section 2 of this Act, this Act shall become effective upon
17 its approval by the Governor or upon its becoming law without such approval.

18 **SECTION 4.**

19 All laws and parts of laws in conflict with this Act are repealed.
