

The House Committee on Transportation offers the following substitute to HR 201:

A RESOLUTION

1 Removing the designation of a portion of Georgia's High Tech Corridor and amending
 2 Part II of a Resolution Act approved May 16, 2002 (Ga. L. 2002, p. 1460); dedicating the
 3 Golden Isles Parkway; and for other purposes.

4 **PART I**

5 WHEREAS, in 2002, the General Assembly, by Res. Act No. 1327, designated Georgia's
 6 High Tech Corridor.

7 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF
 8 GEORGIA that the portion of US 341 from the corporate limits of the City of Perry to the
 9 corporate limits of the City of Brunswick shall no longer be designated as Georgia's High
 10 Tech Corridor. The Department of Transportation is authorized and directed to remove from
 11 such highway any signs identifying such corridor.

12 BE IT FURTHER RESOLVED that Part II of a Resolution Act approved May 16, 2002
 13 (Ga. L. 2002, p. 1460) is amended to read as follows:

14 "BE IT FURTHER RESOLVED that the portion of U.S. Highway 441 from the corporate
 15 limits of the City of Dublin to the point at which it connects with U.S. Highway 341 is
 16 designated as Georgia's High Tech Corridor, and the Department of Transportation is
 17 authorized and directed to place appropriate signs at appropriate locations designating said
 18 highway as provided in this resolution."

19 **PART II**

20 WHEREAS, in 1978, the General Assembly, by Res. Act No. 221, designated a portion of
 21 certain highways as the Golden Isles Highway.

22 WHEREAS, in 1978, the General Assembly, by Res. Act No. 221, designated a portion of
 23 certain highways as the Golden Isles Connector.

1 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF
2 GEORGIA that the portion of the state highway system beginning at the intersection of I16
3 and US 23 and continuing to the intersection of US 23 and US 341 shall continue to be
4 dedicated as the Golden Isles Highway. US 341 from its intersection with US 23 to the City
5 of Brunswick is hereby dedicated as the Golden Isles Parkway. US 341 from its intersection
6 with US 23 to the City of Brunswick shall no longer be dedicated as the Golden Isles
7 Highway. The Department of Transportation is authorized and directed to remove from this
8 portion of the state highway system any signs identifying such corridor as the Golden Isles
9 Highway and replace them with signs identifying such corridor as the Golden Isles Parkway.

10 BE IT FURTHER RESOLVED that the portion of US 341 beginning at I75 and ending in
11 Eastman at the intersection of US 23 is hereby dedicated as the Golden Isles Parkway. This
12 portion of the state highway system shall no longer be dedicated as the Golden Isles
13 Connector. The Department of Transportation is authorized and directed to remove from
14 such highway any signs identifying such corridor as the Golden Isles Connector and replace
15 them with signs identifying such corridor as the Golden Isles Parkway.

16 BE IT FURTHER RESOLVED that Res. Act No. 221, approved April 6, 1978 (Ga. L. 1978,
17 p. 2138) is amended by replacing Golden Isles Highway and Golden Isles Connector with
18 Golden Isles Parkway wherever it is appropriate to resolve any conflicts with this resolution.

19 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is directed to
20 transmit an appropriate copy of this resolution to the Department of Transportation.
