

The House Committee on Transportation offers the following substitute to HR 321:

A RESOLUTION

1 Dedicating certain portions of the state highway system; and for other purposes.

2 **PART I**

3 WHEREAS, Dick Chambers was born January 13, 1924, in Colquitt County to Nellie
4 Alderman Chambers Wilson and John Jovus Chambers; and

5 WHEREAS, he was a retired quality control manager for Bridgeport Brass Company and he
6 served as the Mayor of Funston for 49 years; and

7 WHEREAS, Mayor Chambers was a WWII veteran and was an ammunition bearer for a
8 machine gun squadron that fought in Europe from December 1944 through July 1945 as part
9 of Company G, 38th Infantry; he received the Bronze Star, the Good Conduct Medal, and
10 many other awards for his distinguished service; and

11 WHEREAS, he was a life-long member of the Funston First United Methodist Church where
12 he served as trustee, steward, and chairman of the board, and he also served on the board of
13 the Southwest Georgia Rural Development Board in Camilla, Georgia; and

14 WHEREAS, Mayor Chambers was most proud of the creation of the volunteer fire
15 department, the installation of the water system in Funston, and the construction of a new
16 city hall; and

17 WHEREAS, he was married to Bettie Fisher Chambers and they had two children, seven
18 grandchildren, and four great-grandchildren; and

19 WHEREAS, he was a kind and gentle soul who loved to travel and spend time with his
20 friends and family.

1 **PART II**

2 WHEREAS, SGT David Samuel Collins was stationed out of Fort Campbell, Kentucky,
3 serving in Iraq and was a member of the United States Army's 101st Airborne Division, 1st
4 Battalion, 506th Infantry Regiment, and 4th Brigade Combat Team; and

5 WHEREAS, he lost his life in Iraq on April 9, 2006, while bravely serving his country; and

6 WHEREAS, SGT Collins was 24 years old at the time of his death; and

7 WHEREAS, he grew up just beyond the intersection of SR 515 and Philadelphia Road in
8 Pickens County; and

9 WHEREAS, SGT Collins is survived by his wife, Mara, two young children, James and
10 Elizabeth, and his parents, Sammy Collins and Lynn Dean; and

11 WHEREAS, this courageous soldier, an American patriot, volunteered to confront the
12 dangers, privations, and discomforts of wartime service and, in the name of humanity, strove
13 to keep the peace in Iraq with fortitude and steadfast resolve, making us, as a nation, truly
14 proud; and

15 WHEREAS, all Americans owe a debt of gratitude to the men and women of our armed
16 forces who risk their lives in the defense of freedom, securing the blessings of liberty for this
17 nation and other peoples of the world.

18 **PART III**

19 WHEREAS, Ed Echols was born in Forsyth County, Georgia, on December 28, 1913; and

20 WHEREAS, he was an entrepreneur who owned the Bishop Brothers Auto Auction and
21 founded Echols Brothers House Movers; and

22 WHEREAS, he served three terms as a county commissioner for Clayton County, Georgia,
23 and was a board member of the Clayton County Water Authority; and

24 WHEREAS, Mr. Echols was a farmer and rancher in Henry County commencing in 1943 and
25 was the owner of the Echols Dairy Farm from 1951 to 1973; and

26 WHEREAS, he was a member of the Board of Trustees for the Salem Baptist Church; and

1 WHEREAS, he was the father of five children, all of whom live in Henry County;
2 grandfather of 13 children, 12 of whom live in Henry County; and great-grandfather of 32
3 children; and

4 WHEREAS, this outstanding citizen lived a life of service to his church and his community
5 and helped his communities adapt and prosper in times of fast moving changes.

6 **PART IV**

7 WHEREAS, Kelley L. Courtney was born and raised on Barfield Road in Bibb County,
8 Georgia, and never left home until he and his brother Donnie joined the United States Marine
9 Corps in 1998; and

10 WHEREAS, Kelley L. Courtney rose to the rank of sergeant and was an intelligence officer
11 who was assigned from the 3rd Intelligence Battalion of the III Marine Expeditionary Force
12 to augment the 31st Marine Expeditionary Unit in Iraq and served as a counterintelligence
13 and human intelligence specialist; and

14 WHEREAS, on October 30, 2004, Sgt. Courtney was killed in action in Fallujah, Iraq; and

15 WHEREAS, Sgt. Courtney has been recognized by the Marines for the vital role he played
16 in leadership and his deep personal commitment to the protection and welfare of the citizens
17 of this nation by dedicating a building in his honor at Camp Hansen, Okinawa; and

18 WHEREAS, Sgt. Courtney diligently and conscientiously devoted innumerable hours of his
19 time, talents, and energy toward the betterment of his community, state, and nation; and

20 WHEREAS, his significant organizational and leadership talents, his remarkable patience
21 and diplomacy, his keen sense of vision, and his sensitivity to the needs of the citizens of his
22 nation earned him the respect and admiration of his colleagues and associates; and

23 WHEREAS, he was a person of magnanimous strengths with an unimpeachable reputation
24 for integrity, intelligence, fairness, and kindness, and it is only fitting and proper that an
25 interchange should be named in his honor.

1 **PART V**

2 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF
3 GEORGIA that the portion of SR 37 within the city limits of Funston, Georgia, in Colquitt
4 County, be dedicated as the Edward Sidney "Dick" Chambers Memorial Highway.

5 BE IT FURTHER RESOLVED that the intersection of SR 515 and Philadelphia Road in
6 Pickens County be dedicated as the SGT David Samuel Collins Memorial Interchange.

7 BE IT FURTHER RESOLVED that the portion of SR 20 from the North McDonough city
8 limit to East Lake Road, in Henry County, be dedicated as the Ed Echols Memorial Highway.

9 BE IT FURTHER RESOLVED that the intersection of Hartley Bridge Road and I-75 in Bibb
10 County is dedicated as the Sgt. Kelley L. Courtney Interchange.

11 BE IT FURTHER RESOLVED that the Department of Transportation is authorized and
12 directed to erect and maintain appropriate signs dedicating the road facilities named in this
13 resolution.

14 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
15 and directed to transmit appropriate copies of this resolution to the Department of
16 Transportation, to the family of Edward Sidney "Dick" Chambers, to the family of SGT
17 David Samuel Collins, to the family of Mr. Ed Echols, and to the family of Sgt. Kelley L.
18 Courtney.
