## **A RESOLUTION**

- 1 Honoring and remembering the life of John Strickland Gibson; and for other purposes.
- 2 WHEREAS, John Strickland Gibson, a celebrated attorney and United States Congressman,
- 3 was one of the most distinguished community servants in the history of Georgia; and
- 4 WHEREAS, he was born in Charlton County on January 3, 1893, to William Owen Gibson
- 5 and Julia Ann Vickery Gibson, and he was married to Bessie Thomas in April, 1917; and
- 6 WHEREAS, after moving to Douglas and graduating from Georgia State Normal College, he
- 7 began his legal career at the office of George Mingledorff while he finished a correspondence
- 8 course from LaSalle Extension University and prepared for the bar exam; and
- 9 WHEREAS, he was an aggressive courtroom lawyer who specialized in cross-examination
- and was known for his innate ability to sense the mood of the jury and for his colorful and
- 11 frequently caustic methods of argument; and
- 12 WHEREAS, he became one of Georgia's most feared and admired attorneys, and his
- 13 excellence as a trial lawyer led to his election in 1934 as solicitor general, a position
- 14 equivalent to today's district attorney; and
- 15 WHEREAS, Gibson's popularity continued to grow, and he was elected as a Democrat to the
- 16 United States Congress after the congressman from Georgia's Eighth District, W. Ben Gibbs,
- 17 passed away in 1940; and
- 18 WHEREAS, Congressman Gibson served the public tirelessly through the difficult years of
- 19 World War II, and he is credited with playing a decisive role in the passing of the
- 20 Servicemen's Readjustment Act of 1944, better known as the G.I. Bill; and

1 WHEREAS, during the week of the D-Day invasion of Normandy, a House and Senate

- 2 conference committee was deadlocked on the bill which would provide housing, education,
- 3 and job benefits to returning veterans; and
- 4 WHEREAS, Congressman Gibson received word that the bill was in jeopardy while he was
- 5 at home in Douglasville, Georgia, recovering from an illness, and in a spectacular overnight
- 6 journey, he rushed to Washington to remind his peers that American soldiers needed their full
- 7 support.
- 8 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
- 9 join in remembering the life John Strickland Gibson and honoring his tireless dedication to
- 10 serving his community, state, and country.
- 11 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed to
- 12 transmit an appropriate copy of this resolution to the Georgia Department of the American
- 13 Legion.
