A BILL TO BE ENTITLED AN ACT

1	To amend an Act entitled	"An Act to	provide for homestead	exemptions from Heard	County

- 2 ad valorem taxes for county purposes and from Heard County School District ad valorem
- 3 taxes for educational purposes for certain residents of that county and school district,"
- 4 approved April 13, 1992 (Ga. L. 1992, p. 6107), so as to increase the homestead exemption
- 5 from school district taxes for citizens age 65 and older; to provide for a referendum, effective
- 6 dates, and automatic repeal; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act entitled "An Act to provide for homestead exemptions from Heard County ad
- valorem taxes for county purposes and from Heard County School District ad valorem taxes
- 11 for educational purposes for certain residents of that county and school district," approved
- 12 April 13, 1992 (Ga. L. 1992, p. 6107), is amended by revising Section 3 as follows:
- "SECTION 3.
- 14 Each resident of the Heard County School District who is 65 years of age or older is granted
- an exemption on that person's homestead from all Heard County School District ad valorem
- taxes for educational purposes in the amount of \$20,000.00 of the assessed value of that
- 17 homestead."

- 18 SECTION 2.
- 19 The increase in the exemption from Heard County School District taxes for educational
- 20 purposes provided by Act shall apply to all taxable years beginning after December 31, 2007.
- SECTION 3.
- 22 Unless prohibited by the federal Voting Rights Act of 1965, as amended, the election
- 23 superintendent of Heard County shall call and conduct an election as provided in this section
- 24 for the purpose of submitting this Act to the electors of the Heard County School District for
- 25 approval or rejection. The election superintendent shall conduct that election on the Tuesday

1 next following the first Monday in November, 2007, and shall issue the call and conduct that

- 2 election as provided by general law. The superintendent shall cause the date and purpose of
- 3 the election to be published once a week for two weeks immediately preceding the date
- 4 thereof in the official organ of Heard County. The ballot shall have written or printed
- 5 thereon the words:
- 6 "() YES Shall the Act be approved which provides a new increased homestead
- 7 exemption from Heard County ad valorem taxes for educational purposes
- 8 in the amount of \$20,000.00 of the assessed value of the homestead for
- 9 () NO residents of that school district who are 65 years of age or over?"
- 10 All persons desiring to vote for approval of the Act shall vote "Yes," and those persons
- desiring to vote for rejection of the Act shall vote "No." If more than one-half of the votes
- 12 cast on such question are for approval of the Act, Sections 1 and 2 of this Act shall become
- of full force and effect on January 1, 2008. If the Act is not so approved or if the election is
- 14 not conducted as provided in this section, Sections 1 and 2 of this Act shall not become
- 15 effective and this Act shall be automatically repealed on the first day of January immediately
- 16 following that election date. The expense of such election shall be borne by Heard County.
- 17 It shall be the election superintendent's duty to certify the result thereof to the Secretary of
- 18 State.

19 SECTION 4.

- 20 Except as otherwise provided in Section 3 of this Act, this Act shall become effective upon
- 21 its approval by the Governor or upon its becoming law without such approval.

SECTION 5.

23 All laws and parts of laws in conflict with this Act are repealed.
