- 1 Commending, recognizing, and congratulating Dr. Eugene P. Walker, Ph.D., on the occasion
- 2 of his retirement; and for other purposes.
- 3 WHEREAS, Dr. Eugene P. Walker is a man with a great passion for learning, a man of
- 4 conviction, a man of outstanding moral character, and a man with tremendous compassion
- 5 for others; and
- 6 WHEREAS, Dr. Eugene P. Walker is a native of Thomaston, Georgia, residing in DeKalb
- 7 County since 1969, earning his Bachelor of Arts degree in Social Science at Clark College
- 8 in 1958, a certificate in Southern History at Johns Hopkins University in 1968, a Master of
- 9 Arts degree in History at Atlanta University in 1969, and a Rockefeller Foundation
- 10 Fellowship and Ph.D. in History at Duke University in 1978; and
- 11 WHEREAS, Dr. Walker began his career in public service as a history and social studies
- 12 teacher at Drake High School in his hometown of Thomaston, Georgia, while also coaching
- 13 its basketball and football teams; and
- 14 WHEREAS, Dr. Walker continued his service to the public by teaching history at Clark
- 15 College, later becoming vice president of Personnel and Community Relations at DeKalb
- 16 College, and then advancing to the position of executive vice president at the DeKalb
- 17 Technical Institute; and
- 18 WHEREAS, Dr. Walker was elected and served with great distinction as the Senator for the
- 19 43rd Georgia Senatorial District from 1984 to 1992 where, as the first person of color to hold
- 20 the position of Majority Whip, he was instrumental in garnering support and votes for major
- 21 legislation in education, health care, and economic development; and
- 22 WHEREAS, Dr. Walker was appointed by Governor Zell Miller to the Department of
- 23 Juvenile Justice as its commissioner in 1995, where he served until 1999 when Governor Roy

1 Barnes appointed him to the Parole Board, where he served until his retirement on December

- 2 31, 2006; and
- 3 WHEREAS, his commitment to the community is demonstrated by his service on numerous
- 4 civic, community, and professional groups including the Georgia and National Associations
- 5 of Blacks in Criminal Justice, the American Correctional Association, and the Parole
- 6 Association of Georgia, as well as his service as chairman of the Board of Directors of the
- 7 DeKalb County Development Authority, chairman of the West Care-Georgia Children's
- 8 Center Board of Directors, and the NAACP, where he serves as a lifetime member; and
- 9 WHEREAS, Eugene Walker is a faithful member of the Greenforest Community Baptist
- 10 Church and a devoted husband to his wife of 45 years, Patricia Carter Walker, and a loving
- 11 father, grandfather, and great-grandfather to their three children, five grandchildren, and two
- 12 great-grandchildren; and
- 13 WHEREAS, Dr. Eugene P. Walker is a public servant of outstanding ability, determination,
- and deep social conscience, and it is only fitting and proper that one who has contributed so
- much to this state and its citizens be appropriately recognized.

- 17 join in recognizing Dr. Eugene P. Walker for an outstanding career of public service,
- 18 commending him for his many generous contributions to the people of Georgia, and
