- 3 WHEREAS, during her 14-year tenure as editor of *The Albany Herald*, Kay Read has
- 4 contributed vastly to improving the professionalism and community involvement of the
- 5 newspaper, and she has provided her capable leadership to nearly every aspect of public life

- 11 City Star in 1971, became the senior editor for features at the New York Post in 1989, and
- worked with a public relations agency in New York City before coming to Albany in August

- 15 member of the board of directors of the Georgia First Amendment Foundation, the Georgia
- 16 Chamber of Commerce, and the Georgia Partnership for Excellence in Education, and she
- 17 has tirelessly served the community of Albany on the Albany Area Chamber of Commerce
- 18 Executive Committee, the Albany Rotary Club, the Southwest Georgia Alliance for Progress,
- 19 and the Southwest Georgia Cancer Coalition executive committee; and
- 20 WHEREAS, throughout her career she has maintained a laudable commitment to diversity
- 21 of opinion, preferring editorials that incite conversation rather than consensus, and she has
- 22 transformed the newspaper into a positive force within the community that empowers readers
