

The House Committee on Public Safety and Homeland Security offers the following substitute to SB 290:

A BILL TO BE ENTITLED  
AN ACT

1 To amend Title 6 of the Official Code of Georgia Annotated, relating to aviation, so as to  
2 create the Georgia Aviation Authority; to provide for a short title and a definition; to provide  
3 for the membership, governance, operation, powers, duties, and administrative attachment  
4 of the authority; to provide that the general purpose of the authority shall be to acquire,  
5 operate, maintain, house, and dispose of all state aviation assets; to provide for other matters  
6 related to the authority and its creation; to provide for a performance audit of the authority;  
7 to amend Code Section 32-2-2 of the Official Code of Georgia Annotated, relating to powers  
8 and duties of the Department of Transportation, so as to remove provisions relative to the  
9 authority of that department with respect to state aircraft; to amend Chapter 19 of Title 50  
10 of the Official Code of Georgia Annotated, relating to state government transportation  
11 services, so as to repeal Article 2, the "Air Transportation Act," relating to the powers and  
12 duties of the Department of Transportation with respect to state air transportation; to provide  
13 for other related matters; to provide for sunset provisions; to repeal conflicting laws; and for  
14 other purposes.

15 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

16 **SECTION 1.**

17 Title 6 of the Official Code of Georgia Annotated, relating to aviation, is amended by adding  
18 a new Chapter 5 to read as follows:

19 "CHAPTER 5

20 6-5-1.

21 This chapter shall be known and may be cited as the 'Georgia Aviation Authority Act.'

22 6-5-2.

23 As used in this chapter, the term:

1 (1) 'Authority' means the Georgia Aviation Authority.

2 (2) 'State aircraft' means any aircraft, including equipment, owned, leased, rented,  
3 chartered, or otherwise obtained by the authority.

4 6-5-3.

5 (a) There is created a body corporate and politic to be known as the Georgia Aviation  
6 Authority which shall be deemed to be an instrumentality of the state and a public  
7 corporation, and by that name, style, and title the body may contract and be contracted  
8 with, implead and be impleaded, and bring and defend actions in all courts. The authority  
9 shall consist of the Governor or his or her designee, the Lieutenant Governor or his or her  
10 designee, the Speaker of the House of Representatives or his or her designee, the  
11 commissioner of transportation, the commissioner of public safety, the commissioner of  
12 natural resources, the director of the State Forestry Commission, and three persons from  
13 the aviation business community with one member of the aviation business community to  
14 be appointed by the Governor, one such member to be appointed by the Speaker of the  
15 House of Representatives, and one such member to be appointed by the President of the  
16 Senate. The authority shall make rules and regulations for its own government. It shall  
17 have perpetual existence.

18 (b) The authority is assigned to the Office of Planning and Budget for administrative  
19 purposes only as prescribed in Code Section 50-4-3.

20 (c) The authority may in its discretion employ an executive director and other personnel.  
21 The authority may also by agreement with any department or agency of state government  
22 make use of personnel of such department or agency.

23 (d) The authority may designate personnel positions employed by the authority as peace  
24 officers who shall be required by the terms of their employment to give their full time to  
25 the preservation of public order, the protection of life and property, the detection of crime  
26 and such other duties as may be specified by the authority. Personnel in such positions  
27 shall comply with the requirements of the 'Georgia Peace Officer Standards and Training  
28 Act' contained in Chapter 8 of Title 35 and shall have the power of arrest in the  
29 performance of their duties.

30 6-5-4.

31 (a) The general purpose of the authority shall be to acquire, operate, maintain, house, and  
32 dispose of all state aviation assets, to provide aviation services and oversight of state  
33 aircraft and aviation operations to ensure the safety of state air travelers and aviation  
34 property, to achieve policy objectives through aviation missions, and to provide for the  
35 efficient operation of state aircraft. All aircraft owned or operated as of July 1, 2007, or

1 a later date determined by the Governor, by any other entity of state government shall be  
2 transferred on that date to the custody and control of the authority; provided, however, that  
3 this chapter shall have no application to aircraft owned or operated by the Department of  
4 Defense. On and after July 1, 2007, or a later date determined by the Governor, no other  
5 entity of state government shall acquire, lease, or charter any aircraft other than through the  
6 authority. All state aircraft required for the proper conduct of the business of the several  
7 administrative departments, boards, bureaus, commissions, authorities, offices, or other  
8 agencies of Georgia and authorized agents of the General Assembly, or either branch  
9 thereof, and department owned airfields and their appurtenances shall be managed and  
10 maintained by the authority. The cost for the use of such state aircraft shall be charged by  
11 the authority to the using state entity. The amount of such charge shall be determined by  
12 the authority. The authority shall be authorized to dispose of any state aircraft and apply  
13 the proceeds derived therefrom to the purchase of replacement aviation assets.

14 (b) In the furtherance of its purpose, the authority shall have the power to:

15 (1) Organize, staff, train personnel to operate, maintain, house, purchase, and dispose of  
16 aviation assets;

17 (2) Purchase, maintain, develop, and modify facilities to support aviation assets and  
18 operations;

19 (3) Develop operating, maintenance, safety, security, training, education, and scheduling  
20 standards for state aviation operations and conduct inspections, audits, and other similar  
21 oversight to determine practices and compliance with such standards;

22 (4) Develop an accountability system for state aviation operations and activities;

23 (5) Identify the costs associated with the purchase, operation, maintenance, and  
24 administration of state aircraft and aviation operations and related facilities, training, and  
25 education, develop an appropriate billing structure, and charge agencies and other state  
26 entities for the costs of state aircraft and aviation operations; provided, however, that any  
27 billing to an agency by the authority shall be suspended whenever the Governor declares  
28 a state of emergency on any cost associated with aircraft used during and in response to  
29 the state of emergency;

30 (6) Retain appropriate external consulting and auditing expertise;

31 (7) Engage aviation industry representatives to ensure best practices for state aviation  
32 assets;

33 (8) Delegate certain powers pursuant to this chapter to other state entities; and

34 (9) Otherwise implement appropriate and efficient management practices for state  
35 aviation operations.

36 (c) The authority shall provide support for those state agencies and departments whose  
37 operations require aviation operations. No state entity other than the authority shall be

1 authorized to expend state funds to purchase, lease, rent, charter, maintain, or repair state  
2 aircraft to be used in connection with state business or to employ a person whose official  
3 duties consist of piloting state aircraft without the approval of the authority.

4 (d) The funds and assets of the authority, as well as the performance of the authority, its  
5 services, and equipment, shall be independently audited biennially. The initial audit shall  
6 be concluded no later than November 30, 2009. The results of such audit shall be open to  
7 inspection at reasonable times by any person. A copy of the audit report shall be sent to  
8 the state auditor and the state accounting officer. The authority shall also provide the  
9 Governor, the Speaker of the House, the President of the Senate, the chairperson of the  
10 House Committee on Public Safety and Homeland Security, and the chairperson of the  
11 Senate Committee on Public Safety and Homeland Security with a copy of the independent  
12 audit report which shall include a full report of the activities and services of the authority.  
13 The performance audit report shall be provided no later than December 31, 2009, and every  
14 two years thereafter.

15 6-5-5.

16 In addition to the powers specified in Code Section 6-5-4, the authority shall have the  
17 powers:

18 (1) To have a seal and alter the same at its pleasure;

19 (2) To acquire by purchase, lease, or otherwise and to hold, lease, and dispose of real and  
20 personal property of every kind and character for its corporate purposes;

21 (3) To acquire in its own name by purchase, on such terms and conditions and in such  
22 manner as it may deem proper real property or rights of easements therein or franchises  
23 necessary or convenient for its corporate purposes and to use the same so long as its  
24 corporate existence shall continue and to lease or make contracts with respect to the use  
25 of or disposal of the same in any manner it deems to the best advantage of the authority.

26 No property shall be acquired under this chapter upon which any lien or other  
27 encumbrance exists unless at the time such property is so acquired a sufficient sum of  
28 money is deposited in trust to pay and redeem the fair value of the lien or encumbrance;  
29 and if the authority shall deem it expedient to construct any project on lands which are  
30 a part of the real estate holdings of the state, the Governor is authorized to execute for and  
31 on behalf of the state a lease of the lands to the authority for such parcel or parcels as  
32 shall be needed for a period not to exceed 50 years. If the authority shall deem it  
33 expedient to construct any project on any other lands the title to which shall then be in  
34 the state, the Governor is authorized to convey, for and in behalf of the state, title to such  
35 lands to the authority;

1 (4) To appoint and select officers, agents, and employees, including pilots, maintenance  
2 workers, engineering, architectural, aviation, and construction experts, fiscal agents, and  
3 attorneys, and fix their compensation and otherwise adopt policies that establish a system  
4 of sound personnel management;

5 (5) To make contracts and leases and to execute all instruments necessary or convenient,  
6 including contracts for construction of projects and leases of projects or contracts with  
7 respect to the use of projects which it causes to be erected or acquired; and any and all  
8 political subdivisions, departments, institutions, or agencies of the state are authorized to  
9 enter into contracts, leases, or agreements with the authority upon such terms and for such  
10 purposes as they deem advisable. Without limiting the generality of the above, authority  
11 is specifically granted to any department, board, commission, or agency of the state to  
12 enter into contracts and lease agreements for the use or concerning the use of any  
13 structure, building, or facilities or a combination of any two or more structures, buildings,  
14 or facilities of the authority for a term not exceeding 50 years; and any department, board,  
15 commission, or agency of the state may obligate itself to pay an agreed sum for the use  
16 of the property so leased and also to obligate itself as part of the lease contract to pay the  
17 cost of maintaining, repairing, and operating the property leased from the authority;

18 (6) To accept loans or grants of money or materials or property of any kind from the  
19 United States or any agency or instrumentality thereof upon such terms and conditions  
20 as the United States or the agency or instrumentality may impose;

21 (7) To exercise any power usually possessed by private corporations performing similar  
22 functions, which is not in conflict with the Constitution and laws of this state; and

23 (8) To do all things necessary or convenient to carry out the powers expressly given in  
24 this chapter.

25 6-5-6.

26 All moneys received pursuant to the authority of this chapter shall be deemed trust funds  
27 to be held and applied solely as provided in this chapter.

28 6-5-7.

29 It is found, determined, and declared that the creation of the authority and the carrying out  
30 of its corporate purpose are in all respects for the benefit of the people of this state and are  
31 a public purpose and the authority will be performing an essential governmental function  
32 in the exercise of the power conferred upon it by this chapter.

1 6-5-8.

2 Any action to protect or enforce any rights under this chapter shall be brought in the  
3 Superior Court of Fulton County.

4 6-5-9.

5 This chapter, being for the welfare of the state and its inhabitants, shall be liberally  
6 construed to effect the purposes hereof."

7 **SECTION 2.**

8 Code Section 32-2-2 of the Official Code of Georgia Annotated, relating to powers and  
9 duties of the Department of Transportation, is amended by revising paragraph (16) of  
10 subsection (a) as follows:

11 "(16) Reserved: ~~(A) All state aircraft required for the proper conduct of the business of~~  
12 ~~the several administrative departments, boards, bureaus, commissions, authorities,~~  
13 ~~offices, or other agencies of Georgia and authorized agents of the General Assembly, or~~  
14 ~~either branch thereof, and department owned airfields and their appurtenances shall be~~  
15 ~~managed and maintained by the department. The cost for the use of such state aircraft~~  
16 ~~shall be charged by the department to the using agency. The amount of such charge shall~~  
17 ~~be determined by the department. The department shall be authorized to dispose of any~~  
18 ~~state aircraft and apply the proceeds derived therefrom to the purchase of replacement~~  
19 ~~aircraft when the director of the Office of Planning and Budget shall authorize such~~  
20 ~~actions, notwithstanding any other provisions of law to the contrary.~~

21 ~~(B) The department shall have all those powers and duties formerly set forth in Code~~  
22 ~~Section 50-19-23, which statute relates to the maintenance and operation of state~~  
23 ~~aircraft, supervision of their pilots, and similar matters.~~

24 ~~(C) No department, board, bureau, commission, authority, office, or other agency of~~  
25 ~~Georgia shall be authorized to expend state funds to purchase, lease, rent, charter,~~  
26 ~~maintain, or repair state aircraft to be used in connection with state business or to~~  
27 ~~employ a person whose official duties consist of piloting state aircraft except the~~  
28 ~~Department of Transportation.~~

29 ~~(D) The Department of Administrative Services shall purchase all aircraft for the~~  
30 ~~department in the same manner as other state purchases.~~

31 ~~(E) Anything in this title to the contrary notwithstanding, the State Forestry~~  
32 ~~Commission, the Department of Natural Resources, and the Department of Public~~  
33 ~~Safety may, with the approval of the commissioner of transportation, expend state funds~~  
34 ~~to purchase, lease, rent, charter, maintain, or repair special purpose aircraft necessary~~

1 ~~to conduct the particular business of said agencies and may employ persons whose~~  
 2 ~~official duties consist of piloting said aircraft;"~~

3 **SECTION 3.**

4 Chapter 19 of Title 50 of the Official Code of Georgia Annotated, relating to state  
 5 government transportation services, is amended by repealing and reserving Article 2 as  
 6 follows:

7 "ARTICLE 2

10 ~~This article shall be known and may be cited as the 'Air Transportation Act.'~~

12 ~~As used in this article, the term:~~

17 ~~All state aircraft required for the proper conduct of the business of the several~~  
 18 ~~administrative departments, boards, bureaus, commissions, authorities, offices, or other~~  
 19 ~~agencies of the state or for authorized agents of the General Assembly, or either branch~~  
 20 ~~thereof, shall be managed and maintained by the department. The cost for the use of such~~

 29 ~~Transportation to fly state aircraft upon such pilot's reaching 65 years of age;~~

30 ~~(5) To establish priorities concerning the use of state aircraft;~~

31 ~~(6) To execute such contracts as may be necessary to carry out this article; and~~

1 ~~(7) To assign special purpose state aircraft and personnel to any other department or~~  
2 ~~agency of state government.~~

3 ~~50-19-24.~~

4 ~~The department shall have the following powers and duties:~~

5 ~~(1) To promulgate such rules and regulations as may be necessary to effectuate the~~  
6 ~~purposes of this article; and~~

7 ~~(2) To establish a timetable for bringing all state aircraft under this article.~~

8 ~~50-19-25.~~

9 ~~No department, board, bureau, commission, authority, office, or other agency of the state~~  
10 ~~shall be authorized to expend state funds to purchase, lease, rent, charter, maintain, or~~  
11 ~~repair state aircraft to be used in connection with state business or to employ a person~~  
12 ~~whose official duties consist of piloting state aircraft, except the Department of~~

15 ~~The Department of Administrative Services shall purchase all aircraft for the Department~~  
16 ~~of Transportation in the same manner as other state purchases are made."~~

17 **SECTION 4.**

18 The provisions of this Act shall expire on July 1, 2011, unless the General Assembly acts to  
19 extend these provisions.

20 **SECTION 5.**

21 All laws and parts of laws in conflict with this Act are repealed.
