

House Bill 218 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend Chapter 2 of Title 52 of the Official Code of Georgia Annotated, relating to the  
2 Georgia Ports Authority, so as to change certain provisions for the application of traffic laws  
3 and enforcement by security guards employed with the Georgia Ports Authority; to change  
4 the designation of security guard to peace officer; to require that those employees of the  
5 authority who are authorized to exercise the powers of arrest shall be certified peace officers  
6 subject to the Georgia Peace Officer Standards and Training Council; to provide for related  
7 matters; to provide an effective date; to repeal conflicting laws; and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 style="text-align:center">**SECTION 1.**

10 Chapter 2 of Title 52 of the Official Code of Georgia Annotated, relating to the Georgia Ports  
11 Authority, is amended by revising Code Section 52-2-10, relating to the application of traffic  
12 laws and enforcement by security guards employed with the Georgia Ports Authority, as  
13 follows:

14 "52-2-10.

15 (a)(1) The motor vehicle traffic laws for this state shall apply to all roads within the  
16 jurisdiction of the Georgia Ports Authority; provided, however, that the authority may  
17 determine and declare reasonable, safe, and lawful speed limits on all roads within its  
18 jurisdiction.

19 (2) Those regular employees of the Georgia Ports Authority designated as ~~security~~  
20 ~~guards~~ peace officers shall have the power to arrest for traffic offenses committed on any  
21 property under the jurisdiction of the Georgia Ports Authority.

22 (3) Such arrest may be effected by issuance of a citation, provided the offense is  
23 committed in the presence of the arresting ~~security guard~~ peace officer.

1 (4) A citation issued by a ~~security guard~~ peace officer shall enumerate the specific  
2 charges against the offender and the date on which the offender is to appear and answer  
3 the charges.

4 (5) If the offender fails to appear as specified in the citation, the judge having jurisdiction  
5 of the offense may issue a warrant ordering the apprehension of such person and  
6 commanding that he or she be brought before the court to answer the charges contained  
7 in the citation and the charge of his or her failure to appear as required. The person shall  
8 be allowed to make a reasonable bond to appear on a given date before the court.

9 (6) ~~Security guards~~ Peace officers shall be subject to Chapter 13 of Title 40, relating to  
10 uniform traffic citation and complaint forms.

11 (b) ~~Security guards~~ Peace officers of the Georgia Ports Authority may arrest for violations  
12 of dock related city ordinances where applicable.

13 (c) All powers of arrest granted in this Code section shall exist only on property under the  
14 jurisdiction of the Georgia Ports Authority or while in hot pursuit of one whom the ~~security~~  
15 ~~guard~~ peace officer observed commit an offense within the jurisdiction of the authority as  
16 provided in subsections (a) and (b) of this Code section.

17 (d) All offenders apprehended for offenses committed within the jurisdiction of the  
18 Georgia Ports Authority shall be tried by the appropriate city, county, or state tribunal.

19 (e) ~~Regular employees~~ All peace officers of the Georgia Ports Authority ~~designated as~~  
20 ~~security guards~~ shall ~~not~~ be subject to the requirements of Chapter 8 of Title 35, the  
21 'Georgia Peace Officer Standards and Training Act,' ~~nor shall said guards be subject to~~  
22 ~~Chapter 38 of Title 43, the 'Georgia Private Detective and Security Agencies Act.'~~

23 (f) While in the performance of their duties, ~~those regular employees~~ peace officers of the  
24 Georgia Ports Authority ~~designated as investigators or Georgia certified~~ peace officers shall  
25 have the same powers of arrest and the same powers to enforce law and order as the sheriff  
26 of the county and the chief of police of the county or municipality in this state wherein any  
27 such ~~investigator or Georgia certified~~ peace officer is performing his or her duty. While  
28 in the performance of their duties, any such ~~investigators or Georgia certified~~ peace officers  
29 shall be authorized to exercise such powers and duties as are authorized by law for  
30 members of the Uniform Division of the Department of Public Safety. Such ~~investigators~~  
31 ~~or Georgia certified~~ peace officers shall be subject to the requirements of Chapter 8 of Title  
32 35, the 'Georgia Peace Officer Standards and Training Act,' and are specifically required  
33 to complete the training required for peace officers by that chapter.

34 (g) While in the performance of their duties, ~~those regular employees~~ peace officers of the  
35 Georgia Ports Authority ~~designated as investigators or certified~~ peace officers of the State  
36 ~~of Georgia~~ shall have the right to issue citations to vehicles parked in areas not specifically  
37 designated for the parking of vehicles while on the properties of the Georgia Ports

1 Authority's terminals. The issuance of any such parking citation shall require the person  
2 who parked said vehicle to respond by the payment of a fine in the amount of \$25.00 or by  
3 appearing in the court which handles misdemeanor traffic offenses for the county in which  
4 the terminal is located, in which event the amount of the fine shall be fixed at the discretion  
5 of the judge of said court, but in no event shall the fine exceed \$25.00. In addition to the  
6 right to issue parking citations, ~~those regular employees~~ peace officers of the Georgia Ports  
7 Authority ~~designated as investigators or certified peace officers of the State of Georgia~~  
8 shall have the right to remove improperly parked cars or vehicles in accordance with the  
9 provisions of Code Section 44-1-13."

10 **SECTION 2.**

11 This Act shall become effective upon its approval by the Governor or upon its becoming law  
12 without such approval.

13 **SECTION 3.**

14 All laws and parts of laws in conflict with this Act are repealed.
