

House Bill 349 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act creating the State Court of Colquitt County (originally the City Court of  
2 Colquitt County and established as the Civil and Criminal Court of Colquitt County by Ga.  
3 L. 1968, p. 2139), approved August 7, 1931 (Ga. L. 1931, p. 293), as amended, so as to  
4 prohibit the judge of such court from engaging in the practice of law; to provide for the  
5 compensation of such judge; to provide for construction and for related matters; to provide  
6 an effective date; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act creating the State Court of Colquitt County (originally the City Court of Colquitt  
10 County and established as the Civil and Criminal Court of Colquitt County by Ga. L. 1968,  
11 p. 2139), approved August 7, 1931 (Ga. L. 1931, p. 293), as amended, is amended by adding  
12 a new section as follows:

13 "SECTION 10A.

14 (a) The position of judge of the State Court of Colquitt County shall be a full-time position  
15 and, as provided in subsection (b) of Code Section 15-7-21 of the Official Code of Georgia  
16 Annotated, the full-time judge of the state court shall not engage in the private practice of  
17 law.

18 (b) The judge of said court shall receive an annual salary equal to 70 percent of the gross  
19 salary as defined in subsection (c) of this section which shall be payable out of the funds  
20 of Colquitt County at the same intervals as installments are paid to other county employees.

21 (c) For the purposes of subsection (b) of this section, the term 'gross salary' shall mean the  
22 annual salary received by a superior court judge of the Southern Judicial Circuit, from state  
23 funds only, effective July 1, 2007, plus any increases in said annual salary for superior  
24 court judges, from state funds only, on or after July 1, 2007.

1 (d) Pursuant to Code Section 15-7-22 of the Official Code of Georgia Annotated, the  
2 governing authority of Colquitt County is authorized to supplement the compensation  
3 established by subsections (b) and (c) of this section.

4 (e) The provisions of this section shall supersede and control over any other provisions to  
5 the contrary, including, but not limited to, Section 10 of this Act and Section 3 of an Act  
6 approved April 4, 1979 (Ga. L. 1979, p. 3191)."

7 **SECTION 2.**

8 This Act shall become effective on July 1, 2007.

9 **SECTION 3.**

10 All laws and parts of laws in conflict with this Act are repealed.
