

Senate Resolution 296

ADOPTED

A RESOLUTION

1 Dedicating certain portions of the state highway system; and for other purposes.

2 **PART I**

3 WHEREAS, Julian Abel was born on April 23, 1921, and enlisted on August 20, 1942, to
4 serve his country in the Army Air Force during World War II; and

5 WHEREAS, he was shot down on November 26, 1943; and

6 WHEREAS, this great citizen of Berrien County, Georgia, made the ultimate sacrifice while
7 in service to his country and defending it during time of war; and

8 WHEREAS, this courageous soldier, in the spirit of the American patriot, confronted the
9 dangers, privations, and discomforts of wartime service with steadfast resolve, making us as
10 a nation truly proud; and

11 WHEREAS, all Americans owe a debt of gratitude to the men and women of our armed
12 forces who risk their lives in the defense of freedom and to secure the blessings of liberty for
13 this nation and other peoples of the world.

14 **PART II**

15 WHEREAS, PFC Odom was a member of the 254th Infantry in the United States Army
16 during World War II; and

17 WHEREAS, while serving in Germany, he was killed on April 18, 1945; and

18 WHEREAS, this courageous soldier, in the spirit of the American patriot, confronted the
19 dangers, privations, and discomforts of wartime service with steadfast resolve, making us as
20 a nation truly proud; and

1 WHEREAS, all Americans owe a debt of gratitude to the men and women of our armed
2 forces who risk their lives in the defense of freedom and to secure the blessings of liberty for
3 this nation and other peoples of the world.

4 **PART III**

5 WHEREAS, SFC Bryant H. Roberts was born on January 30, 1920, and served his country
6 in 1942, in the United States Navy aboard the U.S.S. Vincennes during World War II; and

7 WHEREAS, he made the ultimate sacrifice for his country in the name of freedom for all
8 Americans when he was lost at sea in the line of duty; and

9 WHEREAS, the Board of Commissioners of Berrien County deems it fitting and appropriate
10 to honor the service and sacrifice of SFC Bryant H. Roberts by designating a permanent
11 public memorial near his homeplace.

12 **PART IV**

13 WHEREAS, Fred L. Belcher was born in November, 1919, and was drafted in 1942 to serve
14 his country in the Army Air Force during World War II; and

15 WHEREAS, he was captured and held as a prisoner of war in Stalog 17B In Kriems, Austria;
16 and

17 WHEREAS, this great citizen of Berrien County, Georgia, made the ultimate sacrifice while
18 in service to his country and defending it during time of war; and

19 WHEREAS, this courageous soldier, in the spirit of the American patriot, confronted the
20 dangers, privations, and discomforts of wartime service with steadfast resolve, making us as
21 a nation truly proud; and

22 WHEREAS, all Americans owe a debt of gratitude to the men and women of our armed
23 forces who risk their lives in the defense of freedom and to secure the blessings of liberty for
24 this nation and other peoples of the world.

25 **PART V**

26 WHEREAS, Mr. John Paul Ellis lives in Hopeulikit, Georgia, with his wife, Beatrice B.
27 Ellis; and

1 WHEREAS, they have operated a grocery business there since the late 1930s; and

2 WHEREAS, they also ran a farm and raised five children in the community; and

3 WHEREAS, John Paul was a county commissioner in Bulloch County for approximately 25
4 years; and

5 WHEREAS, he was instrumental in obtaining a four-lane road in the county from Hopeulikit
6 to Statesboro; and

7 WHEREAS, it is only fitting to honor a man who has devoted so much of his time to serving
8 his community and the State of Georgia.

9 **PART VI**

10 WHEREAS, Bill Lowery was a dynamic force in the music industry in Georgia for many
11 years; and

12 WHEREAS, Bill Lowery, through his music publishing and recording company, the Lowery
13 Group, recorded songs for such artists as Brenda Lee, Billy Joe Royal, Joe South, the Atlanta
14 Rhythm Section, and Alicia Bridges; and

15 WHEREAS, he was a recognized genius in identifying musical talent and recognizing hit
16 music; and

17 WHEREAS, he was the first non-performer to be inducted into the Georgia Music Hall of
18 Fame; and

19 WHEREAS, it is fitting and proper to dedicate the section of Clairmont Road between
20 Buford Highway and Century Plaza Parkway in DeKalb County as the Bill Lowery Parkway
21 as an appropriate tribute to this giant of the music industry in Georgia.

22 **PART VII**

23 WHEREAS, Carl Kelly began his military career by joining the Jackson National Guard,
24 then called the Jackson Rifles, while he was still in his teens; and

1 WHEREAS, when WWII started, the Jackson National Guard was called upon to train for
2 the war in Europe and Carl Kelly was promoted to 1st Sergeant before he left for Ireland to
3 wait for the invasion at Normandy; and

4 WHEREAS, in St-Lo, France, he was wounded in action and awarded the first of his two
5 bronze stars for gallantry and a Purple Heart; and

6 WHEREAS, when the Korean Conflict began, Sgt. Kelly was immediately sent to Korea
7 where he was awarded a battlefield commission to 2nd Lieutenant after distinguishing
8 himself as a leader of men; and

9 WHEREAS, after recuperating from a wound, he returned to battle and soon after was
10 involved in a battle to save an artillery unit that had been ambushed; Lt. Kelly organized the
11 artillerymen into fighting groups and with complete disregard for his safety, led attack after
12 attack on the enemy forces; and

13 WHEREAS, his conspicuous actions served to center the enemy fire on himself, and finally
14 he was struck by enemy fire and fell mortally wounded; and

15 WHEREAS, before he died he told a friend to tell his wife and children that he loved them
16 very much and would see them in Heaven someday; and

17 WHEREAS, Lt. Kelly was in the military service for 11 years and received three Purple
18 Hearts, three Bronze Stars, and a Silver Star, as well as many other service medals.

19 **PART VIII**

20 WHEREAS, Emmett Henry Austin was born January 28, 1906, in Douglas County, Georgia;
21 and

22 WHEREAS, on October 14, 1923, he married Lena Mae Croker of Paulding County and they
23 then moved to Powder Springs, Georgia, where they resided until their deaths; and

24 WHEREAS, he sharecropped for a few years and in 1932 helped hang electrical wiring and
25 motors when Clark Thread Company built Clarkdale Mills; and

26 WHEREAS, in 1935 he helped build the bridge and Highway 278 into Powder Springs and
27 in 1938 the Highway 92 bridge in Hiram; and

1 WHEREAS, when the new REA was established in 1936, he worked with Glen Florence and
2 Roy Richards to string the first wire for the community; and

3 WHEREAS, over the next several years he wired farmhouses too numerous to mention with
4 the help of his 11 year-old son; and

5 WHEREAS, when 220 volt power became available, he rewired many of these same houses;
6 and

7 WHEREAS, over his career he was an experienced electrician, plumber, mechanic, and
8 highway and bridge builder; and

9 WHEREAS, he raised eight children, 16 grandchildren, and numerous great-grandchildren,
10 many of whom still live in the Powder Springs/Cobb County area.

11 **PART IX**

12 WHEREAS, Mr. Ralph Lively came into this world on Independence Day, July 4, 1910, in
13 Carroll County, Georgia, and was the son of the late Richard Alvin and Susan Smith Lively;
14 and

15 WHEREAS, he was preceded in death by his wife, Carrie, with whom he shared 64 years of
16 wonderful marriage; and

17 WHEREAS, he was known throughout his life for his industry and honest work ethic, and
18 he transported mail during World War II and was a valued employee of the Bell Bomber
19 Company; and

20 WHEREAS, he started the R.A. Lively Bus Line, retired from the Georgia Department of
21 Agriculture, and worked at the Georgia General Assembly for 27 years as the personal aide
22 to Speaker of the House Thomas B. Murphy; and

23 WHEREAS, he touched the hearts and lives of everyone he met and was esteemed
24 throughout the General Assembly as a dedicated worker and a gentleman of unimpeachable
25 character; and

26 WHEREAS, he was a successful gardener who won a blue ribbon for his roses at the
27 Tallapoosa Garden Club Flower Show; and

1 WHEREAS, he is survived by his many wonderful children and their spouses, E.D. and
2 Labera Lively, Dolores and Herbert Newman, Reita and Bill Mendum, Alton and Shelby
3 Lively, Mack and Shelby Lively, Jack and Margaret Lively; 17 grandchildren; 38
4 great-grandchildren; and six great-great grandchildren; and

5 WHEREAS, he was a faithful member of Tallapoosa First Baptist Church and belonged to
6 Masonic Lodge No. 126; and

7 WHEREAS, Georgia has lost one of its most distinguished citizens with the unfortunate
8 passing of Ralph Lively and it is only fitting that a lasting memorial to his well-lived life
9 should be created.

10 **PART X**

11 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF
12 GEORGIA that the members of this body dedicate the Hardy Creek Bridge on US 82, in
13 Berrien County, as the POW Julian Abel Memorial Bridge.

14 BE IT FURTHER RESOLVED that the members of this body dedicate the Five Mile Creek
15 Bridge on SR 168, in Berrien County, as the PFC Elwood W. Odom Memorial Bridge

16 BE IT FURTHER RESOLVED that the members of this body dedicate the Ten Mile Creek
17 Bridge on SR 168 near Nashville in Berrien County as the MIA/KIA Bryant H. Roberts, SFC
18 Memorial Bridge.

19 BE IT FURTHER RESOLVED that the members of this body dedicate the Withlacoochee
20 River Bridge on SR 76 west of Nashville, in Berrien County, as the POW Fred L. Belcher
21 Memorial Bridge.

22 BE IT FURTHER RESOLVED that the members of this body dedicate the portion of US
23 80/SR 26 from Portal to Hopeulikit, in Bulloch County, as the John Paul Ellis Highway.

24 BE IT FURTHER RESOLVED that the members of this body dedicate the portion of
25 Clairmont Road between Buford Highway and Century Plaza Parkway in DeKalb County
26 as the Bill Lowery Parkway.

27 BE IT FURTHER RESOLVED that the portion of SR 16 East from the railroad tracks to the
28 Jackson city limits, in Butts County, be dedicated as the Lt. Carl Kelly Memorial Highway.

1 BE IT FURTHER RESOLVED that the Powder Creek Bridge on C. H. James Parkway (SR
2 6/U.S. 278) between Powder Springs-Dallas Road and Hill Road, in Cobb County, be
3 dedicated as the Emmett Henry Austin Memorial Bridge.

4 BE IT FURTHER RESOLVED that the members of this body dedicate the portion of US 78
5 from the US 27 bypass in Bremen, Georgia, to Pine Grove Road, west of Bremen, in
6 Haralson County, as the Ralph Lively Memorial Highway.

7 BE IT FURTHER RESOLVED that the Department of Transportation is authorized and
8 directed to erect and maintain appropriate signs dedicating the road facilities named in this
9 resolution.

10 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed
11 to transmit appropriate copies of this resolution to the Department of Transportation, to the
12 family of Julian Abel, to the family of PFC Elwood W. Odom, to the family of Bryant H.
13 Roberts, to the family of Fred L. Belcher, to John Paul Ellis, to the family of Bill Lowery,
14 to the family of Lt. Carl Kelly, to the family of Emmett Henry Austin, and to the family of
15 Ralph Lively.
