

Senate Bill 385

A BILL TO BE ENTITLED  
AN ACT

1 To amend Article 1 of Chapter 9 of Title 3 of the Official Code of Georgia Annotated,  
2 relating to the sale of alcoholic beverages by public carriers and nonprofit organizations, so  
3 as to provide for the licensing of limousine carriers to sell alcoholic beverages; to provide  
4 for annual applications and fees; to provide for a sticker for each vehicle authorized; to  
5 provide for limitations on such annual permit; to provide for compliance with law regarding  
6 furnishing alcoholic beverages to minors; to provide for related matters; to repeal conflicting  
7 laws; and for other purposes.

8 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

9 **SECTION 1.**

10 Article 1 of Chapter 9 of Title 3 of the Official Code of Georgia Annotated, relating to the  
11 sale of alcoholic beverages by public carriers and nonprofit organizations, is amended by  
12 adding a new Code Section 3-9-4 to read as follows:

13 "3-9-4.

14 (a) Notwithstanding any provision contained in this title or any other law, the  
15 commissioner may issue an annual permit authorizing a limousine carrier to sell alcoholic  
16 beverages for consumption only in the vehicle supplied by the limousine carrier upon the  
17 filing of an application and payment of a fee of \$50.00 by such limousine carrier that holds  
18 a certificate issued in accordance with Article 3 of Chapter 7 of Title 46. In addition to the  
19 permit fee, the limousine carrier shall pay an annual fee of \$15.00 for each vehicle to be  
20 authorized for the sale of alcoholic beverages. The commissioner shall issue a sticker for  
21 each vehicle so authorized.

22 (b) A permit issued in accordance with this Code section shall not authorize the wholesale  
23 purchase of alcoholic beverages by a limousine carrier and only authorizes purchase from  
24 a retail dealer. A permit issued in accordance with this Code section shall be subject to any  
25 law regulating the time for selling such beverages.

1 (c) A permit issued in accordance with this Code section shall not authorize a limousine  
2 carrier to purchase or sell an alcoholic beverage in a location where the sale of such  
3 alcoholic beverage is unlawful.

4 (d) Limousine carriers holding permits issued in accordance with this Code section shall  
5 comply with the provisions of paragraph (1) of subsection (a) of Code Section 3-3-23."

6 **SECTION 2.**

7 All laws and parts of laws in conflict with this Act are repealed.
