A RESOLUTION

- 1 Recognizing and congratulating the Georgia Drugs and Narcotics Agency on the occasion
- 2 of its 100th anniversary; and for other purposes.
- 3 WHEREAS, in 1906, the General Assembly passed an act creating the Office of the Food
- 4 and Drug Inspector, set forth its duties, and assigned the position to the Georgia State
- 5 Department of Agriculture; and
- 6 WHEREAS, in 1908, the Georgia General Assembly passed another act, separating the
- 7 Office of the Chief Drug Inspector from the Office of the Food Inspector, and provided that
- 8 the Commissioner of Agriculture should appoint, upon recommendation of the Georgia State
- 9 Board of Pharmacy, a Chief Drug Inspector; and
- 10 WHEREAS, T. A. Cheatham, a pharmacist, was appointed as the first Chief Drug Inspector
- whose time was at the disposal of the Commissioner of Agriculture and whose duties were
- 12 to visit and inspect establishments where drugs were manufactured or sold, to report any
- 13 violations to the Commissioner, and to perform other duties as assigned by the
- 14 Commissioner; and
- 15 WHEREAS, again in 1939, the General Assembly passed an act providing for the
- 16 appointment of the Chief Drug Inspector by the State Board of Pharmacy and transferring
- 17 the position from the Department of Agriculture to the Board of Pharmacy; and
- 18 WHEREAS, beginning in 1947, the General Assembly passed a series of acts authorizing the
- 19 Chief Drug Inspector to hire assistant drug inspectors needed to assist with the duties of the
- 20 office; and
- 21 WHEREAS, in 1964, in response to the growing problems in this area, the General Assembly
- 22 passed another act granting the Chief Drug Inspector and his assistants the authorization and
- 23 powers possessed by sheriffs, thereby allowing them to arrest violators; and

1 WHEREAS, in 1976, as a result of a study by the State Merit System the name of the Office

- 2 of the Chief Drug Inspector was changed to the Georgia Drugs and Narcotics Agency; and
- 3 WHEREAS, since its origins in 1908, this agency has been led by only 14 men, all of whom
- 4 have been pharmacists; and
- 5 WHEREAS, the Georgia Drugs and Narcotics Agency is currently under the leadership of
- 6 Director Bill Atkins and Deputy Director Rick Allen, a pharmacist and former president of
- 7 the International Narcotic Enforcement Officers Association, and 2008 marks the agency's
- 8 100th year of inspecting, investigating, and enforcing the narcotic and drug laws of this state.
- 9 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 10 the members of this body recognize and honor the Georgia Drugs and Narcotics Agency on
- 11 the occasion of its 100th anniversary and commend its employees for protecting the health,
- safety, and welfare of Georgia's citizens.
- 13 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
- 14 and directed to transmit an appropriate copy of this resolution to Director Bill Atkins.
