A BILL TO BE ENTITLED AN ACT

- 1 To amend Article 2 of Chapter 4 of Title 20 of the Official Code of Georgia Annotated,
- 2 relating to technical and adult education, so as to change the name of the Department of
- 3 Technical and Adult Education to the Technical College System of Georgia; to amend the
- 4 Official Code of Georgia Annotated to change references to reflect such changes; to provide
- 5 for related matters; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

- 8 Article 2 of Chapter 4 of Title 20 of the Official Code of Georgia Annotated, relating to
- 9 technical and adult education, is amended by revising Code Section 20-4-14, relating to the
- 10 Department of Technical and Adult Education, as follows:
- 11 "20-4-14.
- 12 (a) There is established a established the Technical College System of Georgia, formerly
- 13 <u>known as the</u> Department of Technical and Adult Education.
- 14 (b) The department shall exercise state level leadership, management, and operational
- 15 control over schools, programs, and services authorized in this article and Article 3 of this
- 16 chapter.
- 17 (c) The Department of Technical and Adult Education Technical College System of
- 18 Georgia shall be empowered to:
- 19 (1) Approve occupational programs below the baccalaureate level; provided, however,
- any courses to be transferable to units of the University System of Georgia shall be
- approved by the Board of Regents of the University System of Georgia;
- 22 (2) Receive and hold title to property, equipment, money, and materials;
- 23 (3) Operate instructional services projects, also known as student live work projects, in
- 24 those occupational areas which require specific skills or competency mastery that can
- best be obtained or demonstrated in a laboratory environment with clients, real items, or

1 projects, including, but not limited to, carpentry, child care, aviation, welding, and

- 2 automotive repair, and, in connection with such projects:
- 3 (A) Receive, retain, and utilize donations, fees, and moneys generated as a result of the sale of such services or projects;
- 5 (B) Retain any unexpended student live work funds from year to year;
- 6 (C) Expend retained student live work funds for any student live work project or for
- 7 the benefit of instructional programs at the technical institute; and
- 8 (D) Acquire, improve, and sell real or personal property in connection with student live
- 9 work projects, provided that all acquisitions and sales of real property in connection
- with student live work projects shall be approved by the state board;
- 11 (4) Solicit and receive funds from the general public, corporate underwriters, and
- 12 foundations;
- 13 (5) Contract with other state, federal, or local public or private schools and other entities,
- individuals, or other legal entities for the provision of programmatic or administrative
- services or activities the department deems necessary; and
- 16 (6) Administer and supervise programs in accordance with standards, rules, regulations,
- and policies of the State Board of Technical and Adult Education."

18 SECTION 2.

- 19 Title 20 of the Official Code of Georgia Annotated, relating to education, is amended by
- 20 replacing "Department of Technical and Adult Education" with "Technical College System
- 21 of Georgia" wherever the former occurs in:
- 22 (1) Code Section 20-2-161.2, relating to the Youth Apprenticeship Program;
- 23 (2) Code Section 20-2-270, relating to establishment of state-wide network of regional
- 24 educational service agencies;
- 25 (3) Code Section 20-2-320, relating to the Education Information Steering Committee,
- 26 identification of data to implement Quality Basic Education Program, and state-wide
- 27 comprehensive educational information network;
- 28 (4) Code Section 20-3-39, relating to the reassignment of responsibilities for operation and
- 29 management of public libraries;
- 30 (5) Code Section 20-3-85, relating to study examining postsecondary text availability in
- 31 alternative formats;
- 32 (6) Code Section 20-3-485, relating to definitions regarding the Georgia HERO Scholarship;
- 33 (7) Code Section 20-3-519, relating to definitions regarding HOPE scholarships and grants;
- 34 (8) Code Section 20-3-519.2, relating to eligibility requirements for a HOPE scholarship
- at a public postsecondary institution and scholarship amount;

1 (9) Code Section 20-3-519.3, relating to eligibility requirements for a HOPE scholarship at

- 2 a private postsecondary institution and scholarship amount;
- 3 (10) Code Section 20-3-519.5, relating to eligibility requirements for a HOPE grant at a
- 4 branch of the Georgia Department of Technical and Adult Education and limitation on hours
- 5 of eligibility;
- 6 (11) Code Section 20-3-519.6, relating to HOPE GED vouchers;
- 7 (12) Code Section 20-3-561, relating to management of the Georgia Military College vested
- 8 in the board of trustees;
- 9 (13) Code Section 20-4-11, relating to powers of the State Board of Technical and Adult
- 10 Education;
- 11 (14) Code Section 20-4-16, relating to funding of such board;
- 12 (15) Code Section 20-4-17, relating to agencies receiving federal funds and transfers of
- 13 personnel;
- 14 (16) Code Section 20-4-18, relating to the management and control of adult literacy and
- 15 postsecondary technical education and schools;
- 16 (17) Code Section 20-4-21, relating to tuition fees;
- 17 (18) Code Section 20-4-22, relating to management and control of quick start program;
- 18 (19) Code Section 20-4-25, relating to membership in the retirement system by certain
- 19 professional personnel;
- 20 (20) Code Section 20-4-26, relating to membership in the retirement system of employees
- 21 of schools formerly operated by local boards of education or area postsecondary education
- 22 boards;
- 23 (21) Code Section 20-4-31, relating to initial sick and annual leave;
- 24 (22) Code Section 20-4-34, relating to rights and benefits of former employees of State
- 25 Board of Postsecondary Vocational Education;
- 26 (23) Code Section 20-4-36, relating to obtaining alternative formats for textbooks used by
- 27 students with disabilities;
- 28 (24) Code Section 20-4-42, relating to the administration of the industry services training
- 29 program;
- 30 (25) Code Section 20-4-45, relating to equipment procurement and use;
- 31 (26) Code Section 20-14-8, relating to general powers and duties of the Education
- 32 Coordinating Council;
- 33 (27) Code Section 20-14-27, relating to reports required of the Office of Student
- 34 Achievement;
- 35 (28) Code Section 20-14-50, relating to creation of the postsecondary accountability
- 36 assessment program, adoption of performance measures, report cards, and audit; and

1 (29) Code Section 20-16-3, relating to the creation of the Georgia Higher Education

2 Facilities Authority, appointment of members, terms of office, and officers.

3 SECTION 3.

- 4 Chapter 8 of Title 3 of the Official Code of Georgia Annotated, relating to the sale of
- 5 alcoholic beverages at publicly owned facilities, is amended by revising subsection (a) of
- 6 Code Section 3-8-6, relating to technical institutes, service of alcoholic beverages, and
- 7 regulation and tax, as follows:
- 8 "(a) As used in this Code section, the term 'technical institute' means any facility which
- 9 is operated by a unit of the Department of Technical and Adult Education <u>Technical</u>
- 10 <u>College System of Georgia</u> and which has a business conference center capable of
- accommodating 200 people or more incident to its operation."

12 SECTION 4.

- 13 Chapter 11 of Title 12 of the Official Code of Georgia Annotated, relating to the Georgia
- 14 Youth Conservation Corps, is amended by revising Code Section 12-11-10, relating to
- 15 coordinated job training and placement services, as follows:
- 16 "12-11-10.
- Whenever available and appropriate, job training and placement services and education
- opportunities provided through other federal, state, and local programs such as through the
- 19 Department of Education, the Department of Labor, the Department of Technical and Adult
- 20 Education Technical College System of Georgia, and the Board of Regents of the
- 21 University System of Georgia shall be coordinated with projects and programs developed
- under this chapter to assist eligible corps members. Coordinated services may include, but
- are not limited to, remedial and postsecondary education, job placement assistance, adult
- literacy training, job search skills, and job application skills. Whenever possible, eligible
- 25 corps members without a high school diploma shall receive coordinated services that
- provide an opportunity to obtain an equivalent high school diploma."

27 SECTION 5.

- 28 Chapter 5 of Title 35 of the Official Code of Georgia Annotated, relating to the Georgia
- 29 Public Safety Training Center, is amended by revising Code Section 35-5-6, relating to the
- 30 effect of chapter on powers of Board of Corrections, State Board of Pardons and Paroles, and
- 31 Department of Technical and Adult Education, as follows:

- 1 "35-5-6.
- Nothing in this chapter shall be considered as altering current state laws establishing the
- 3 powers and authority of the Board of Corrections or the State Board of Pardons and
- 4 Paroles. Furthermore, nothing in this chapter shall prevent the Department of Technical
- 5 and Adult Education Technical College System of Georgia from providing any course of
- 6 instruction including, but not limited to, instructional courses, certified training, advanced
- 7 instruction, or classes for or pertaining to public safety first responders and emergency
- 8 medical personnel."

9 **SECTION 6.**

- 10 Code Section 40-5-22 of the Official Code of Georgia Annotated, relating to persons not to
- 11 be licensed, minimum ages for licensees, school attendance requirements, and driving
- training requirements, is amended by revising paragraph (4) of subsection (a.1) as follows:
- 13 "(4) The Department of Technical and Adult Education Technical College System of
- 14 Georgia shall be responsible for compliance and noncompliance data for students
- pursuing a general educational development (GED) diploma."

SECTION 7.

- 17 Title 43 of the Official Code of Georgia Annotated, relating to professions and businesses,
- 18 is amended by replacing "Department of Technical and Adult Education" with "Technical
- 19 College System of Georgia" wherever the former occurs in:
- 20 (1) Code Section 43-7-3, relating to definitions regarding barbers;
- 21 (2) Code Section 43-7-11, relating to requirements for license to practice barbering;
- 22 (3) Code Section 43-7-13, relating to requirements for license to teach barbering;
- 23 (4) Code Section 43-10-1, relating to definitions regarding cosmetologists;
- 24 (5) Code Section 43-10-9, relating to application for certificate of registration, examination,
- 25 work permit, reciprocity, study at technical college or public school, and eligibility of
- 26 licensed barber;
- 27 (6) Code Section 43-10-10, relating to display of certificate of registration, renewal,
- 28 reinstatement, continuing education requirements, and exemptions;
- 29 (7) Code Section 43-10-20, relating to teaching of cosmetology in prisons and certification
- 30 of registration;
- 31 (8) Code Section 43-10A-7, relating to licensing requirement and exceptions for professional
- 32 counselors, social workers, and marriage and family therapists;
- 33 (9) Code Section 43-26-34, relating to the creation of the Georgia Board of Examiners of
- 34 Licensed Practical Nurses, appointment of members, terms, filling of vacancies, meetings,
- and reimbursement of expenses; and

1 (10) Code Section 43-26-55, relating to certification standards and requirements and

2 issuance and renewal of certificates for qualified medication aides.

3 SECTION 8.

- 4 Code Section 45-20-2 of the Official Code of Georgia Annotated, relating to definitions
- 5 regarding personnel administration, is amended by revising subparagraph (BB) of paragraph
- 6 (15) as follows:
- 7 "(BB) The officers, officials, and employees of postsecondary technical schools which
- 8 are operated by the Department of Technical and Adult Education Technical College
- 9 <u>System of Georgia</u>, except those officers, officials, and employees already eligible to
- be covered by the state merit system by law or executive order;

SECTION 9.

- 12 Title 48 of the Official Code of Georgia Annotated, relating to revenue and taxation, is
- amended by replacing "Department of Technical and Adult Education" with "Technical
- 14 College System of Georgia" wherever the former occurs in:
- 15 (1) Code Section 48-7-40.5, relating to tax credits for employers providing approved
- 16 retraining programs; and
- 17 (2) Code Section 48-7-41, relating to basic skills education program credits.

18 SECTION 10.

- 19 Title 50 of the Official Code of Georgia Annotated, relating to state government, is amended
- 20 by replacing "Department of Technical and Adult Education" with "Technical College
- 21 System of Georgia" wherever the former occurs in:
- 22 (1) Code Section 50-13-2, relating to definitions relative to the Georgia Administrative
- 23 Procedure Act;
- 24 (2) Code Section 50-16-38, relating to all state entities to acquire real property through the
- 25 State Properties Commission, exceptions, procedure for handling acquisition requests, and
- 26 funds for acquisitions;
- 27 (3) Code Section 50-25-14, relating to distribution of legislative information; and
- 28 (4) Code Section 50-27-3, relating to definitions relative to the Georgia Lottery for
- 29 Education Act.

30 **SECTION 11.**

- 31 Title 20 of the Official Code of Georgia Annotated, relating to education, is amended by
- 32 replacing "department" with "system" wherever the former occurs in:

- 1 (1) Code Section 20-4-27, relating to service in the state merit system;
- 2 (2) Code Section 20-4-28, relating to compensation of employees of schools appointed after
- 3 July 1, 1987;
- 4 (3) Code Section 20-4-29, relating to salary and benefit plan of employees of schools
- 5 formerly operated by local board of education or area postsecondary technical education
- 6 board;
- 7 (4) Code Section 20-4-30, relating to compensation of classified employees electing to
- 8 become classified;
- 9 (5) Code Section 20-4-32, relating to the accrual of sick leave; and
- 10 (6) Code Section 20-4-33, relating to days off with pay and the accrual of sick leave.

11 SECTION 12.

12 All laws and parts of laws in conflict with this Act are repealed.
