

## House Bill 919 (COMMITTEE SUBSTITUTE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend Chapter 27 of Title 50 of the Official Code of Georgia Annotated, relating to  
2 lottery for education, so as to provide for a Georgia Lottery Corporation Board of Directors;  
3 to provide for certain duties for the board of directors; to provide for certain duties for the  
4 Georgia Lottery Corporation's chief executive officer; to provide for a Georgia Lottery  
5 Corporation Legislative Oversight Committee; to provide for related matters; to provide for  
6 an effective date; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 Chapter 27 of Title 50 of the Official Code of Georgia Annotated, relating to lottery for  
10 education, is amended by revising subsections (a) and (c) of Code Section 50-27-5, relating  
11 to membership of the board of directors of the Georgia Lottery Corporation, as follows:

12 "(a) ~~The As of January 1, 2009, the~~ corporation shall be governed by a redesignated board  
13 of directors composed of ~~seven~~ nine members to be appointed as follows: three members  
14 shall be appointed by the Governor, three members shall be appointed by the Speaker of  
15 the House of Representatives, and three members shall be appointed by the Lieutenant  
16 Governor. Members shall be appointed with a view toward equitable geographic  
17 representation."

18 "(c) Members shall serve terms of five years, except that of the initial members appointed,  
19 ~~three~~ five shall be appointed for initial terms of two years, two shall be appointed for initial  
20 terms of four years, and two shall be appointed for initial terms of five years. Any vacancy  
21 occurring on the board shall be filled by the ~~Governor by appointment~~ official who  
22 originally appointed the board member vacating his or her seat for the unexpired term."



1 Appropriations, the chairperson of the House Committee on Economic Development and  
 2 Tourism, the chairperson of the House Committee on Higher Education, the chairperson  
 3 of the House Committee on Education, the chairperson of the House Committee on  
 4 Regulated Industries, two members of the Senate appointed by the Lieutenant Governor,  
 5 one of whom shall be a member of the minority party, and two members of the House of  
 6 Representatives appointed by the Speaker of the House of Representatives, one of whom  
 7 shall be a member of the minority party. The chairpersons of ~~such committees~~ the Senate  
 8 Economic Development Committee and the House Committee on Regulated Industries  
 9 shall serve as cochairpersons of the oversight committee. The oversight committee shall  
 10 periodically inquire into and review the operations of the Georgia Lottery Corporation, as  
 11 well as periodically review and evaluate the success with which the authority is  
 12 accomplishing its statutory duties and functions as provided in this chapter. The oversight  
 13 committee may conduct any independent audit or investigation of the authority it deems  
 14 necessary.

15 (b) The Georgia Lottery Corporation shall provide the oversight committee not later than  
 16 December 1 of each year with a complete report of the level of participation of minority  
 17 businesses in all retail and major procurement contracts awarded by the corporation.

18 (c) The Georgia Lottery Corporation shall provide the oversight committee not later than  
 19 December 1 of each year with a complete report of the corporation's salaries and incentive  
 20 packages for that year."

## 21 SECTION 6.

22 This Act shall become effective on January 1, 2009.

## 23 SECTION 7.

24 All laws and parts of laws in conflict with this Act are repealed.
