**AS PASSED SENATE**

A BILL TO BE ENTITLED  
AN ACT

1 To amend Article 1 of Chapter 2 of Title 27 of the Official Code of Georgia Annotated,  
2 relating to hunting, trapping, or fishing, so as to change certain provisions relating to game  
3 and fish license, permit, tag, and stamp fees; to provide effective dates; to repeal conflicting  
4 laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 **SECTION 1A.**

7 Article 1 of Chapter 2 of Title 27 of the Official Code of Georgia Annotated, relating to  
8 hunting, trapping, or fishing, is amended by revising Code Section 27-2-23, relating to game  
9 and fish license, permit, tag, and stamp fees, as follows:

18 (9) The board is authorized to provide by rule for a fee not to exceed \$19.00 for resident  
 19 daily, seasonal, or annual use permits, licenses, or stamps to hunt and fish on or otherwise  
 20 use specially designated streams, lakes, or wildlife management areas or a fee not to  
 21 exceed \$73.00 for nonresident permits, licenses, or stamps issued under this paragraph.  
 22 (10) Any resident or nonresident who purchases any hunting, fishing, hunting/fishing,  
 23 or sportsman license, or any combination thereof, within 30 days prior to the expiration  
 24 date of such license or combination of licenses held by him or her shall receive a \$2.75  
 25 reduction of the combined fee for all annual licenses purchased in a single transaction  
 26 during such period."

27 **SECTION 1B.**

28 Said article is further amended by revising said Code section as follows:

32	<u>(10) Any resident or nonresident who purchases any hunting, fishing, hunting/fishing,</u>		
33	<u>or sportsman license, or any combination thereof, within 30 days prior to the expiration</u>		
34	<u>date of such license or combination of licenses held by him or her shall receive a \$2.50</u>		

1 reduction of the combined fee for all annual licenses purchased in a single transaction  
2 during such period."

3 **SECTION 2.**

4 (a) This Act shall become effective on July 1, 2008, except as otherwise provided by  
5 subsection (b) of this section.

6 (b) Section 1B of this Act shall become effective on March 31, 2012.

7 **SECTION 3.**

8 All laws and parts of laws in conflict with this Act are repealed.
