## A RESOLUTION

- 1 Recognizing and commending the Georgia Crisis Intervention Team; and for other purposes.
- 2 WHEREAS, mental illness is a serious medical condition that affects children, adolescents,
- 3 adults, and the elderly; and
- 4 WHEREAS, in response to the need for Georgia's law enforcement officers to better
- 5 understand and deal with issues arising from persons with mental illness, the Georgia Crisis
- 6 Intervention Team (CIT) program was developed in 2004; and
- 7 WHEREAS, the CIT program trains law enforcement officers to effectively and humanely
- 8 handle children and adults in psychiatric crisis and to seek community services for them in
- 9 lieu of incarceration when appropriate; and
- 10 WHEREAS, the CIT program is recognized by the mental health community as one of the
- 11 finest law enforcement training programs in the nation; and
- 12 WHEREAS, the National Alliance on Mental Illness (NAMI) has collaborated with the
- 13 Crisis Intervention Team advisory board to ensure that Georgia law enforcement officers are
- 14 provided with skills necessary to interact with persons in psychiatric crisis and to de-escalate
- 15 volatile situations; and
- 16 WHEREAS, over 2,000 law enforcement officers from 150 law enforcement agencies in
- 17 Georgia have received CIT training since 2004; and
- 18 WHEREAS, the Crisis Intervention Team advisory board is composed of the following
- 19 governmental agencies, private organizations, and businesses: Atlanta Alliance on
- 20 Developmental Disabilities; Atlanta Police Department; Clayton County Community Service
- 21 Board; Clinic for the Education, Treatment and Prevention of Addiction; Consumer
- 22 Representative; DeKalb County Magistrate Court Judge; Georgia Department of Human
