## A BILL TO BE ENTITLED AN ACT

1 To amend Title 43 of the Official Code of Georgia Annotated, relating to professions and 2 licenses, so as to make revisions to certain provisions relating to professions and licenses; to provide that a designee of the division director of the professional licensing boards may 3 4 sign and attest orders and processes; to amend certain requirements relating to applications 5 for certification as a registered interior designer; to revise provision relating to inspector at auctions; to provide for service of documents and applications relating to geologists upon the 6 7 division director at his or her office; to repeal certain provisions relating to license by 8 reciprocity for massage therapists; to revise provisions relating to license by endorsement for 9 massage therapists; to provide for certain education and training requirements satisfactory 10 for the issuance of physical therapist licenses; to provide for licensure by endorsement for 11 physical therapists; to provide for the establishment of the renewal period for expired

licenses for veterinarians and veterinary technicians by the division director; to provide for

related matters; to repeal conflicting laws; and for other purposes.

- 16 Title 43 of the Official Code of Georgia Annotated, relating to professions and businesses,
- 17 is amended by revising subsection (b) of Code Section 43-1-3, relating to duties of division
- 18 director and serving notice or process on boards through the division director, as follows:
- 19 "(b) All orders and processes of the professional licensing boards shall be signed and
- attested by the division director, or his or her designee, in the name of the particular
- 21 professional licensing board, with the seal of such board attached. Any notice or legal
- process necessary to be served upon any of the professional licensing boards may be served
- 23 upon the division director."

SECTION 2.

2 Said title is further amended by revising paragraph (5) of subsection (b) of Code Section

- 3 43-4-32, relating to applications for certificates of registration, requirements, term of
- 4 certificates, and renewal relative to registered interior designers, as follows:
- 5 "(5) Except as otherwise provided in subsection (c) of this Code section, provides proof
- 6 that the applicant has acquired a minimum four-year degree or first professional degree
- 7 conferred by a college or university whose program is accredited by the National
- 8 Architectural Accrediting Board or by another national or regional accrediting
- 9 organization recognized by the board in a program of study in architecture or in a
- program of study in interior design approved by the Foundation for Interior Design
- 11 Research Council for Interior Design Accreditation or in a substantially equivalent
- program of study approved by the board."

SECTION 3.

- 14 Said title is further amended by revising Code Section 43-6-18.1, relating to inspector at
- 15 auctions, as follows:

- 17 The commission shall have a full-time an inspector with full inspection rights and
- privileges for all auctions conducted in this state. This inspector shall have the right to
- inspect any activity or lack thereof which may be a violation of this chapter or any
- documents or records pertaining to auction activities and to report any and all such
- violations or any improper or unlicensed practice, including but not limited to trust account
- 22 violations."
- SECTION 4.
- 24 Said title is further amended by revising Code Section 43-19-7, relating to service of appeals,
- 25 documents, and legal process on division director relative to geologists, as follows:
- 26 "43-19-7.
- All appeals from a decision of the board, all documents or applications required by law to
- be filed with the board, and any notice or legal process to be served upon the board shall
- be filed with or served upon the division director at his <u>or her</u> office <del>in Atlanta</del>."
- 30 SECTION 5.
- 31 Said title is further amended by revising Code Section 43-24A-12, relating to license by
- 32 reciprocity relative to massage therapists, as follows:

- 1 "43-24A-12.
- 2 Any applicant for a license by reciprocity as a massage therapist must submit a completed
- 3 application upon a form and in such manner as the board prescribes, accompanied by
- 4 applicable fees, and evidence satisfactory to the board that:
- 5 (1) The applicant is at least 18 years of age;
- 6 (2) The applicant is of good moral character. For purposes of this paragraph, 'good moral
- 7 character' means professional integrity and a lack of any conviction for acts involving
- 8 moral turpitude where the underlying conduct relates to the applicant's fitness to practice
- 9 massage therapy;
- 10 (3) The applicant agrees to provide the board with any and all information necessary to
- 11 perform a criminal background check and expressly consents and authorizes the board
- or its representative to perform such a check; and
- 13 (4) The applicant is currently licensed as a massage therapist in another jurisdiction,
- state, or territory of the United States or foreign country which requires standards for
- licensure considered by the board to be equivalent to the requirements for licensure under
- this chapter. Reserved."

17 SECTION 6.

- 18 Said title is further amended by revising paragraph (4) of Code Section 43-24A-13, relating
- 19 to license by endorsement relative to massage therapists, as follows:
- 20 "(4) The applicant <u>is</u> either:
- 21 (A) Is currently licensed as a massage therapist in another jurisdiction, state, or
- territory of the United States or foreign country which requires standards for licensure
- considered by the board to be equivalent to the requirements for licensure under this
- chapter; or
- 25 (B) Has current certification by the National Certification Board for Therapeutic
- 26 Massage and Bodywork or an equivalent certification approved by the National
- 27 Commission for Certifying Agencies."

28 SECTION 7.

- 29 Said title is further amended by revising paragraph (2) of Code Section 43-33-12, relating
- 30 to requirements for license to practice physical therapy, as follows:
- 31 "(2) Has satisfactorily passed an examination prepared or approved by the board <u>and has</u>
- 32 <u>acquired any additional education and training required by the board;</u> and"

SECTION 8.

2 Said title is further amended by revising Code Section 43-33-15, relating to reciprocity

3 relative to licenses of physical therapists, as follows:

5 The board may grant to a person licensed in another state or territory of the United States

full privileges to engage in equivalent practice authorized by this chapter without taking

an examination, provided:

(1) That such person is properly licensed under the laws of another state or territory or

9 the United States; and

(2) That the requirements for licensing in such other state or territory of the United States

are substantially equal to the requirements for a similar license in this state. <u>The board</u>

may, in its discretion, waive the examination provided for in paragraph (2) of Code

Section 43-33-12 and may, subject to the provisions under Code Sections 43-33-18 and 43-33-19, grant to a person licensed in another state or territory of the United States full

privileges to engage in an equivalent practice authorized by this chapter to any person

who has qualifications the board determines to be the substantial equivalent of the

qualifications described under paragraph (1) of Code Section 43-33-12 and who is

properly licensed under the laws of another state or territory of the United States;

provided, however, that the license held by such person was issued after an examination

which, in the judgment of the board, is the equivalent of the standards established by the

board. In waiving the examination requirement, the board may require additional

education or training."

23 SECTION 9.

24 Said title is further amended by revising subsection (b) of Code Section 43-50-40, relating

to renewal of licenses and registrations, reinstatement, waiver of fee, continuing education,

26 and inactive status relative to veterinarians and veterinary technicians, as follows:

27 "(b) Any person who shall practice veterinary medicine or veterinary technology after the

expiration of his or her license or registration and willfully or by neglect fail to renew such

license or registration shall be practicing in violation of this article, provided that any

person may renew an expired license or registration within one year of the date of its

expiration the period established by the division director in accordance with Code Section

32 <u>43-1-4</u> by making written application for renewal and paying the <del>current renewal fee plus</del>

all delinquent renewal applicable fees. After one year has elapsed from the date of the

expiration the time period established by the division director has elapsed, such license or

registration may be reinstated in accordance with the rules of the board."
