## A BILL TO BE ENTITLED AN ACT

- 1 To amend Title 47 of the Official Code of Georgia Annotated, relating to retirement and
- 2 pensions, so as to change the name of the Board of Regents for the University System of
- 3 Georgia to the Board of Higher Education for the Higher Education System of Georgia and
- 4 to change the name of the Department of Technical and Adult Education to the Division of
- 5 Community Colleges where ever such names occur within the title; to provide for related
- 6 matters; to repeal conflicting laws; and for other purposes.

## 7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 To amend Title 47 of the Official Code of Georgia Annotated, relating to retirement and
- 10 pensions, is amended by replacing "Board of Regents for the University System of Georgia"
- 11 with the "Board of Higher Education for the Higher Education System of Georgia," by
- 12 replacing "board of regents" with "board of higher education," by replacing "university
- 13 system" with "higher education system," and by replacing "Department of Technical and
- 14 Adult Education" with "Division of Community Colleges" where ever the former terms
