A RESOLUTION

1 Recognizing and commending Margaret J. Levine for her support of the Georgia
2 International Law Enforcement Exchange and inviting her to appear before the House of
3 Representatives; and for other purposes.

5 for the Georgia Power Company; and

7 Company, and as director of corporate security, she oversees investigations, threat
