A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act to reincorporate the City of Roswell in the County of Fulton, approved  
2 April 19, 2000 (Ga. L. 2000, p. 3844), as amended, particularly by an Act approved May 29,  
3 2007 (Ga. L. 2007, p. 4287), so as to change the corporate limits; to provide for related  
4 matters; to repeal conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 style="text-align:center">**SECTION 1.**

7 An Act to reincorporate the City of Roswell in the County of Fulton, approved April 19,  
8 2000 (Ga. L. 2000, p. 3844), as amended, particularly by an Act approved May 29, 2007  
9 (Ga. L. 2007, p. 4287), is amended by revising Section 1.20 as follows:

10 style="text-align:center">"SECTION 1.20.  
11 style="text-align:center">Reincorporation.

12 The boundaries of this city shall be as described in the complete legal description attached  
13 hereto and set forth as Exhibit 'A,' and as same may be altered from time to time in  
14 accordance with applicable laws. The city engineer or his or her designee shall prepare a  
15 map to be designated 'Official Map of the Corporate Limits of the City of Roswell,  
16 Georgia,' showing the corporate boundaries as the same may exist as of the date of  
17 adoption of this charter. The city engineer or his or her designee shall prepare a written  
18 description of the corporate boundaries as shown on said map. Said map and description  
19 shall be retained permanently in the office of the city clerk as the official map and  
20 description of the corporate boundaries of the city. Immediately upon alteration of the  
21 corporate boundaries made pursuant to law from time to time, the city engineer shall  
22 indicate such alterations by making appropriate changes in or additions to said official map  
23 and description. A redrawn map shall supersede for all purposes the entire map or maps  
24 which it is designated to replace. Photographic, typed, or other copies of such map or

1 description certified by the city clerk shall be admitted as evidence in all courts and shall  
2 have the same force and effect as with the original map or description."

3 **SECTION 2.**

4 Said Act is further amended by revising Exhibit "A" of such Act as follows:

13 point located at the intersection of said extended centerline of Willeo Creek with the  
14 Southeast bank of the Chattahoochee River; going thence in a northerly and easterly  
15 direction along the meanderings of the south and southeast bank of the Chattahoochee  
16 River a distance of Twelve Thousand Two Hundred Eighty (12,280) feet, more or less,  
17 to the intersection of the East right-of-way of Georgia Highway #9, formerly known as  
18 U.S. Highway #19, and also known as Roswell Road, with the South bank of the  
19 Chattahoochee River, which point is the Point of Beginning.

20 The above-described boundary may encompass, overlap, or intrude upon all or a portion  
21 of lands owned by or under the jurisdiction of the government of the United States of  
22 America, its agents or its instrumentalities, including the National Parks Service, and also  
23 may encompass, overlap, or intrude upon lands owned by or under the jurisdiction of the  
24 government of the State of Georgia, its agents or its instrumentalities, including the  
25 Georgia Department of Natural Resources. In such event there shall be overlapping  
26 jurisdiction to the extent allowed by law. In the event any portion of the above-described  
27 boundary or property within the boundary of the City of Roswell be found by state or  
28 federal law to be ultra vires, unlawful, or unconstitutional, the boundary of the City of  
29 Roswell shall be changed from the existing boundary to a boundary which excludes such  
30 lands. Said new boundary shall begin at the point where the current boundary intersects  
31 with the state or federal land so excluded and going in a counter-clockwise direction along  
32 the portion of the boundary line of such excluded portion which is contiguous with the  
33 current City of Roswell property before the exclusion, to the point where the boundary of  
34 such excluded land intersects with the above described boundary of the City of Roswell  
35 and then continuing along the above-described boundary. In the event any interior land is  
36 excluded, the description of the City of Roswell shall be changed by excepting from the  
37 description of the City of Roswell the property so excluded according to its description.
