## AS PASSED SENATE

# A BILL TO BE ENTITLED AN ACT

1	To provide a homestead exemption from Glynn County School District ad valorem taxes for
2	educational purposes for the full value of the homestead for residents of that school district
3	who are 65 years of age or older and whose income does not exceed \$40,000.00; to provide
4	for definitions; to specify the terms and conditions of the exemption and the procedures
5	relating thereto; to provide for applicability; to provide for a referendum, effective dates, and
6	automatic repeal; to repeal conflicting laws; and for other purposes.
7	BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:
8	SECTION 1.
9	(a) As used in this Act, the term:
10	(1) "Ad valorem taxes for educational purposes" means all ad valorem taxes for
11	educational purposes levied by, for, or on behalf of the Glynn County School District,
12	including, but not limited to, ad valorem taxes to pay interest on and to retire county
13	school district bonded indebtedness.
14	(2) "Homestead" means homestead as defined and qualified in Code Section 48-5-40 of
15	the O.C.G.A., as amended.
16	(3) "Income" means Georgia taxable net income determined pursuant to Chapter 7 of
17	Title 48 of the O.C.G.A., as amended, for state income tax purposes.
18	(4) "Senior citizen" means a person who is 65 years of age or older on or before January
19	1 of the year in which application for the exemption under this Act is made.
20	(b) Each resident of the Glynn County School District who is a senior citizen shall be
21	granted an exemption on that person's homestead from all Glynn County School District ad
22	valorem taxes for educational purposes for the full value of that homestead. The exemption
23	under this subsection shall only be granted if that person's income, together with the income
24	of the spouse who also occupies and resides at such homestead, does not exceed \$40,000.00
25	for the immediately preceding year.

(c) A person shall not receive the homestead exemption granted by subsection (b) of this
section unless the person or person's agent files an application with the tax commissioner of
Glynn County giving the person's age and such additional information relative to receiving
such exemption as will enable the tax commissioner to make a determination regarding the
initial and continuing eligibility of such owner for such exemption. The tax commissioner
shall provide application forms for this purpose.

7 (d) The exemption shall be claimed and returned as provided in Code Section 48-5-50.1 of 8 the O.C.G.A., as amended. The exemption shall be automatically renewed from year to year 9 as long as the owner occupies the residence as a homestead. After a person has filed the 10 proper application as provided in subsection (c) of this section, it shall not be necessary to make application thereafter for any year, and the exemption shall continue to be allowed to 11 12 such person. It shall be the duty of any person granted the homestead exemption under this Act to notify the tax commissioner of Glynn County in the event that person for any reason 13 becomes ineligible for that exemption. 14 15 (e) The exemption granted by subsection (b) of this section shall not apply to or affect any 16 state ad valorem taxes, county ad valorem taxes for county purposes, municipal ad valorem taxes for municipal purposes, or independent school district ad valorem taxes for educational 17 18 purposes. The homestead exemption granted by subsection (b) of this section shall be in

- 19 addition to and not in lieu of any other homestead exemption applicable to Glynn County
- 20 School District ad valorem taxes for educational purposes.
- (f) The exemption granted by this Act shall apply to all taxable years beginning on or afterJanuary 1, 2009.

## **SECTION 2.**

24 Unless prohibited by the federal Voting Rights Act of 1965, as amended, the election 25 superintendent of Glynn County shall call and conduct an election as provided in this section for the purpose of submitting this Act to the electors of the Glynn County School District for 26 27 approval or rejection. The election superintendent shall conduct that election on the date of the November, 2008, state-wide general election and shall issue the call and conduct that 28 election as provided by general law. The election superintendent shall cause the date and 29 purpose of the election to be published once a week for two weeks immediately preceding 30 the date thereof in the official organ of Glynn County. The ballot shall have written or 31 printed thereon the words: 32

33 "() YES Shall the Act be approved which provides a homestead exemption from
34 Glynn County School District ad valorem taxes for educational purposes for
35 () NO the full value of the homestead for residents of that school district who are
36 65 years of age or older and whose income does not exceed \$40,000.00?"

All persons desiring to vote for approval of the Act shall vote "Yes," and those persons 1 desiring to vote for rejection of the Act shall vote "No." If more than one-half of the votes 2 3 cast on such question are for approval of the Act, Section 1 of this Act shall become of full force and effect on January 1, 2009. If the Act is not so approved or if the election is not 4 conducted as provided in this section, Section 1 of this Act shall not become effective and 5 this Act shall be automatically repealed on the first day of January immediately following 6 that election date. The expense of such election shall be borne by Glynn County. It shall be 7 the election superintendent's duty to certify the result thereof to the Secretary of State. 8

## **SECTION 3.**

- 10 Except as otherwise provided in Section 2 of this Act, this Act shall become effective upon
- 11 its approval by the Governor or upon its becoming law without such approval.

## **SECTION 4.**

13 All laws and parts of laws in conflict with this Act are repealed.
