The House Committee on Education offers the following substitute to HB 1031:

A BILL TO BE ENTITLED AN ACT

- 1 To amend Part 3 of Article 16 of Chapter 2 of Title 20 of the Official Code of Georgia
- 2 Annotated, relating to student health in elementary and secondary education, so as to require
- 3 each public high school in this state which has an interscholastic athletics program to have
- 4 at least one functional automated external defibrillator on site at such school at all times for
- 5 use during emergencies; to provide for legislative findings; to define a term; to provide for
- 6 requirements on maintaining and using the defibrillator; to provide for state funding; to
- 7 provide for related matters; to repeal conflicting laws; and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

- 10 The General Assembly finds that, although rare, sudden death in teenagers does occur. The
- 11 General Assembly further finds that in recent years, there have been instances of cardiac
- 12 arrest in high school students participating in interscholastic athletic events and practices.
- 13 In instances of cardiac arrest, time is critical, and even with quick response from emergency
- 14 personnel, it may not be fast enough for successful cardiopulmonary resuscitation. The
- 15 General Assembly finds that automated external defibrillators are inexpensive and are not
- 16 difficult to operate by lay persons as well as trained emergency personnel.
- 17 SECTION 2.
- 18 Part 3 of Article 16 of Chapter 2 of Title 20 of the Official Code of Georgia Annotated,
- 19 relating to student health in elementary and secondary education, is amended by adding a
- 20 new Code section to read as follows:
- 21 "20-2-775.
- 22 (a) As used in this Code section, the term 'automated external defibrillator' means a
- 23 defibrillator which:
- 24 (1) Is capable of cardiac rhythm analysis;

1 (2) Will charge and be capable of being activated to deliver a countershock after

- 2 electrically detecting the presence of certain cardiac dysrhythmias; and
- 3 (3) Is capable of continuously recording cardiac dysrhythmia at the scene with a
- 4 mechanism for transfer and storage or for printing for review subsequent to use.
- 5 (b) No later than July 1, 2008, each public high school in this state which has an
- 6 interscholastic athletics program shall have at least one functional automated external
- defibrillator on site at such school at all times and easily accessible during any school
- 8 related function, including athletic practices, athletic competitions, and other occasions
- 9 where students and others will be present, for use during emergencies.
- 10 (c) Each high school possessing and maintaining an automated external defibrillator shall:
- 11 (1) Ensure that expected users of the automated external defibrillator receive American
- 12 Heart Association or American Red Cross training in cardiopulmonary resuscitation and
- automated external defibrillator use or complete an equivalent nationally recognized
- 14 course;
- 15 (2) Notify the appropriate emergency medical services system of the existence and
- location of the automated external defibrillator prior to said automated external
- defibrillator being placed in use;
- 18 (3) Ensure that the automated external defibrillator is maintained and tested according
- to the manufacturer's operational guidelines;
- 20 (4) Ensure that there is involvement of a licensed physician or other person authorized
- by the composite board in the site's automated external defibrillator program to ensure
- compliance with requirements for training, notification, and maintenance; and
- 23 (5) Ensure that designated personnel activate the emergency medical services system as
- soon as reasonably possible after any person renders emergency care or treatment to a
- 25 person in cardiac arrest by using an automated external defibrillator and reports any
- 26 clinical use of the automated external defibrillator to the licensed physician or other
- person authorized by the composite board who is supervising the program.
- 28 (d) Subject to appropriations by the General Assembly, the Department of Education shall
- 29 provide funds to local school systems to assist in the purchase of automated external
- defibrillators pursuant to this Code section.
- 31 (e) The department and local school systems shall use diligent efforts to identify private
- 32 sources of funding or donation of funding and equipment to meet the requirements of this
- 33 Code section."

SECTION 3.

35 All laws and parts of laws in conflict with this Act are repealed.
