

House Bill 1375

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act providing a new charter for the City of Lavonia, approved May 13, 2002
2 (Ga. L. 2002, p. 5809), as amended, particularly by an Act approved May 30, 2003
3 (Ga. L. 2003, p. 3908), and by an Act approved May 17, 2004 (Ga. L. 2004, p. 4294), so as
4 to change and extend the corporate limits of said city; to repeal conflicting laws; and for
5 other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act providing a new charter for the City of Lavonia, approved May 13, 2002
9 (Ga. L. 2002, p. 5809), as amended, particularly by an Act approved May 30, 2003
10 (Ga. L. 2003, p. 3908), and by an Act approved May 17, 2004 (Ga. L. 2004, p. 4294), is
11 amended by striking subsection (a) of Section 1.11 and inserting in its place the following:

12 "(a) The boundaries of this city shall be as described in:

13 (1) An Act approved June 4, 1964 (Ga. L. 1964, Ex. Sess., p. 2008);

14 (2) An Act approved April 16, 1999 (Ga. L. 1999, p. 4553);

15 (3) Any annexation action taken by the city pursuant to general law and shown as part
16 of the corporate limits on the official map of the corporate limits of the City of Lavonia
17 dated February 15, 2003, which map is retained in the office of the mayor of the city,
18 with such alterations as may be made from time to time in the manner provided by law;

19 (4) In addition to the present territory included within the corporate limits of the city, the
20 corporate limits shall specifically include the following described road and right of way,
21 all of which are located in Franklin County, Georgia:

22 'All that tract or parcel of land lying and being in the 206 District G.M. of Franklin
23 County, Georgia, and consisting of the right of way of Georgia Highway 17 extending
24 from the present corporate limits of Lavonia in a southerly direction to its intersection
25 with Lankford Road;' and

1 (5) In addition to the present territory included within the corporate limits of the city, the
2 corporate limits shall specifically include the following described road and right of way,
3 all of which are located in Franklin County, Georgia:

4 'All that tract or parcel of land lying and being in the 206 District G.M. of Franklin
5 County, Georgia, and consisting of the right of way of Georgia Highway 17 extending
6 from the present corporate limits of Lavonia located at the intersection of Georgia
7 Highway 17 and Lankford Road to the line representing the southern most intersection
8 of the rights of way of Georgia Highway 17 and Grady School Road.

9 All references to roads, highways, and public rights of way in this subsection shall
10 specifically include the current width of said public road, street, highway, drive, circle,
11 or other rights of way and specifically include the entire right of way.

12 The boundaries of this city at all times shall be shown on a map, a written description, or
13 any combination thereof to be retained permanently in the office of the mayor and to be
14 designated, as the case may be: 'Official Map of the corporate limits of the City of Lavonia,
15 Georgia.' Photographic, typed, or other copies of such map or description certified by the
16 city manager shall be admitted as evidence in all courts and shall have the same force and
17 effect as with the original map or description."

18 **SECTION 2.**

19 All laws and parts of laws in conflict with this Act are repealed.
