

## House Bill 521 (RULES COMMITTEE SUBSTITUTE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend Article 5 of Chapter 2 of Title 47 of the Official Code of Georgia Annotated,  
2 relating to service creditable toward retirement benefits under the Employees' Retirement  
3 System of Georgia, so as to provide that a member of such retirement system may obtain  
4 creditable service for prior service as a member of the Georgia Judicial Retirement System  
5 or the District Attorneys' Retirement System; to provide for notice and the transfer or  
6 payment of funds; to provide conditions for an effective date and automatic repeal; to repeal  
7 conflicting laws; and for other purposes.

8 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

9 **SECTION 1.**

10 Article 5 of Chapter 2 of Title 47 of the Official Code of Georgia Annotated, relating to  
11 service creditable toward retirement benefits under the Employees' Retirement System of  
12 Georgia, is amended by adding a new Code section to read as follows:

13 "47-2-101.

14 (a) Any member of this retirement system who was previously a member of the Georgia  
15 Judicial Retirement System but who did not vest for a benefit under such retirement system  
16 may obtain creditable service in this retirement system for prior service for which he or she  
17 was credited as a member of such retirement system as provided in this Code section.

18 (b) Any member wishing to obtain creditable service as provided in subsection (a) of this  
19 Code section who has not withdrawn his or her contributions to such retirement system  
20 may elect to have all contributions made by or on behalf of such member transferred from  
21 such retirement system to this retirement system. Any such member shall notify the board  
22 of trustees of this retirement system and of the Georgia Judicial Retirement System not  
23 later than December 31, 2008, or within 90 days after first becoming a member of this  
24 retirement system, whichever date is later, and the Board of Trustees of the Georgia  
25 Judicial Retirement System shall transfer to the board of trustees of this retirement system  
26 all employer and employee contributions paid by or on behalf of the employee, together

1 with regular interest thereon. Such member may supplement such contribution in any  
2 amount he or she desires.

3 (c) Any member wishing to obtain creditable service as provided in subsection (a) of this  
4 Code section who has withdrawn his or her contributions to such retirement system may  
5 elect to have all employer contributions made on his or her behalf transferred from such  
6 retirement system to this retirement system. Any such member shall notify the board of  
7 trustees of this retirement system and of the Georgia Judicial Retirement System not later  
8 than December 31, 2008, or within 90 days after first becoming a member of this  
9 retirement system, whichever date is later, and the Board of Trustees of the Georgia  
10 Judicial Retirement System shall transfer to the board of trustees of this retirement system  
11 all employer contributions paid on his or her behalf, together with regular interest thereon.  
12 Such member may supplement such contribution in any amount he or she desires.

13 (d) Upon receipt of the funds provided for in of subsection (b) or (c) of this Code section,  
14 the board of trustees of this retirement system shall credit the member with the number of  
15 years of creditable service which such contributions will warrant without creating any  
16 accrued actuarial liability as to this retirement system, but not more than the actual number  
17 of years of creditable service for which he or she was credited as a member of the Georgia  
18 Judicial Retirement System.

19 (e) Any member of this retirement system who was previously a member of the District  
20 Attorney's Retirement System created by Chapter 13 of this title prior to July 1, 1998, but  
21 who did not vest for a benefit under such retirement system, may obtain creditable service  
22 in this retirement system for prior service for which he or she was credited as a member of  
23 such retirement system as provided in this Code section. In order to be eligible for such  
24 creditable service, the member shall make application as prescribed by the board of trustees  
25 not later than December 31, 2008, provide proof of such prior service, and pay such  
26 amount as determined by the actuary as necessary to grant such benefit without creating  
27 any accrued actuarial liability as to this retirement system.

28 (f) No creditable service may be obtained pursuant to the provisions of this Code section  
29 for any period for which creditable service has been or may be obtained in any other state  
30 or local public retirement system."

## 31 SECTION 2.

32 This Act shall become effective on July 1, 2008, only if it is determined to have been  
33 concurrently funded as provided in Chapter 20 of Title 47 of the Official Code of Georgia  
34 Annotated, the "Public Retirement Systems Standards Law"; otherwise, this Act shall not  
35 become effective and shall be automatically repealed in its entirety on July 1, 2008, as  
36 required by subsection (a) of Code Section 47-20-50.

**SECTION 3.**

2 All laws and parts of laws in conflict with this Act are repealed.
