

House Bill 1388

A BILL TO BE ENTITLED
AN ACT

1 To provide for an advisory referendum election to be held in Telfair County for the purpose
2 of ascertaining whether the form of government in Telfair County should be changed from
3 a board of commissioners consisting of five members elected from commissioner districts
4 with the chairperson elected by the board members from among their number to a board of
5 commissioners consisting of four members elected from commissioner districts and a fifth
6 member to serve as a chairperson elected by the electors from the county at large; to provide
7 for procedures, requirements, and other matters relative thereto; to make a certain
8 declaration; to repeal conflicting laws; and for other purposes.

9 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

10 **SECTION 1.**

11 It is the purpose of this Act to provide for an advisory referendum within Telfair County to
12 determine if the voters of said county desire the governing authority be changed from a board
13 of commissioners consisting of five members elected from commissioner districts with the
14 chairperson elected by the board members from among their number to a board of
15 commissioners consisting of four members elected from commissioner districts and a fifth
16 member to serve as a chairperson elected by the electors from the county at large.

17 **SECTION 2.**

18 (a) It shall be the duty of the election superintendent of Telfair County to issue the call for
19 an advisory referendum election for the purpose of submitting the following question to the
20 voters of said county to determine whether the majority of electors voting at said election
21 prefer that the governing authority of Telfair County be changed from a board of
22 commissioners consisting of five members elected from commissioner districts with the
23 chairperson elected by the board members from among their number to a board of
24 commissioners consisting of four members elected from commissioner districts and a fifth
25 member to serve as a chairperson elected by the electors from the county at large. The

1 superintendent shall set the date of such election for the date of the November, 2008, general
2 election. The superintendent shall issue the call for such election at least 60 days prior to the
3 date thereof. The superintendent shall cause the date and purpose of the election to be
4 published once a week for two weeks immediately preceding the date thereof in the official
5 organ of Telfair County. The ballot shall have printed thereon the following:

6 "Advisory Referendum Election

- 7 () YES Shall the governing authority of Telfair County be changed from a board of
8 commissioners consisting of five members elected from commissioner
9 () NO districts with the chairperson elected by the board members from among
10 their number to a board of commissioners consisting of four members
11 elected from commissioner districts and a fifth member to serve as a
12 chairperson elected by the electors from the county at large?"

13 (b) It shall be the duty of the election superintendent of Telfair County to hold and conduct
14 the advisory election provided for in this section and to tabulate the results of such election.
15 It shall be the further duty of said superintendent to certify the results of said election to the
16 Secretary of State and to each member of the General Assembly whose senatorial or
17 representative district lies wholly or partially within Telfair County. The expense of such
18 election shall be borne by Telfair County.

19 (c) It is found, determined, and declared that the holding of an advisory referendum election
20 as provided for in this section is in all respects for the benefit of the people of Telfair County
21 and is for a public purpose and is an essential governmental function for which public funds
22 may be expended.

23 **SECTION 3.**

24 All laws and parts of laws in conflict with this Act are repealed.
