## A RESOLUTION

- 1 Recognizing and commending Jay Davis for his support of the Georgia International Law  
2 Enforcement Exchange and inviting him to appear before the House of Representatives; and  
3 for other purposes.
- 4 WHEREAS, Jay Davis has outstandingly served as the Chairman and Chief Executive  
5 Officer of the National Distributing Company, Inc.; and
- 6 WHEREAS, Mr. Davis's commitment to his community and others is demonstrated by his  
7 active service to many community organizations and charities as well as his services on  
8 educational boards such as the Board of Overseers for Terry College of Business, chairman  
9 of the Terry College Campaign Steering Committee, and Board of Trustees for the University  
10 of Georgia Foundation; and
- 11 WHEREAS, Jay Davis is also most noted for his tremendous and long-standing support for  
12 the Georgia International Law Enforcement Exchange (GILEE) program and for his service  
13 as the chairman of the GILEE board; and
- 14 WHEREAS, with the support of talented people like Mr. Jay Davis, GILEE has been able  
15 to grow and develop first-rate programs for the national and international exchange of  
16 outstanding law enforcement personnel, allowing such expert police officers and public  
17 safety leaders to learn from each other through hands-on meetings and operations around the  
18 country and around the world; and
- 19 WHEREAS, the valuable support of Jay Davis and others has helped GILEE achieve a state,  
20 national, and international reputation as a leader in the exchange of law enforcement ideas  
21 and initiatives; and

1 WHEREAS, such an exchange of information has lead to the tremendous growth of effective  
2 public safety initiatives around the globe, thereby increasing national security and world  
3 peace and generally making our world a better and safer place; and

4 WHEREAS, it is only fitting and proper that this man who has personally contributed so  
5 much to public safety and security be appropriately recognized.

6 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that  
7 the members of this body honor and commend Jay Davis for his outstanding service to the  
8 State of Georgia, to the United States, and to world peace.

9 BE IT FURTHER RESOLVED that Jay Davis is invited to appear before the House of  
10 Representatives at a date and time to be determined by the Speaker.
