- 5 that have achieved success in colleges and universities throughout the state and the nation;

- 7 WHEREAS, this institution, which was founded in modest quarters in Tallulah Falls,
- 8 Georgia, in 1909, has flourished and now grown to national prominence; and
- 9 WHEREAS, Tallulah Falls School offers a demanding and rewarding education with a
- 10 highly qualified faculty and an impressive student to faculty ratio of 12:1; and
- 11 WHEREAS, Tallulah Falls School is a national leader in providing a tuition cost significantly
