## A RESOLUTION

1 Dedicating certain portions of the state highway system; and for other purposes.

### 2 **PART I**

3 WHEREAS, Sheriff D. J. Connell served Cook County as the sheriff for many years; and

4 WHEREAS, during his years of faithful service, he worked diligently, above and beyond the  
5 call of duty; and

6 WHEREAS, due to his hard work and dedication, the people of Cook County live in a safe,

8 WHEREAS, the Board of Commissioners of Cook County strongly believe that Sheriff D. J.  
9 Connell should be honored for his service to the community; and

10 WHEREAS, it is only fitting to recognize his years of service to Cook County and the State  
11 of Georgia.

13 WHEREAS, the veterans of service in the United States military have given of their time,  
14 energy, and sometimes their lives to secure the blessings of freedom for all the citizens of  
15 this great country; and

16 WHEREAS, the sacrifices these great men and women have made to protect our nation  
17 should never be taken for granted or allowed to fade into distant memory; and

18 WHEREAS, it is only fitting that a lasting tribute to memorialize the unselfish patriotism of  
19 these special men and women should be created to perpetuate the memory of their great

2 WHEREAS, Fred DeLoach, Jr., was born on May 17, 1929, in Valdosta, Georgia, to Fred  
3 DeLoach, Sr., and Cobbie Pedrick DeLoach; and

4 WHEREAS, he attended Central Grammar, Valdosta Junior High, and Valdosta High School  
5 and graduated from Gordon Military High School in 1944; and

6 WHEREAS, he continued his education at the University of Georgia and graduated with a  
7 Bachelor of Science degree in 1947; and

8 WHEREAS, Fred DeLoach, Jr., served as the chairman of the group that brought Gold Kist  
9 to Lowndes County; and

10 WHEREAS, he owned and operated DeLoach Hardware from 1956 to 1990 and also did  
11 some farming; and

12 WHEREAS, he served as chairman of the Lowndes County Board of Commissioners from  
13 1976 to 1992, and during this time, he also served as president of the Association County  
14 Commissioners of Georgia, chairman of the Board of Community Affairs, and as a member  
15 of Governor Joe Frank Harris's Growth Strategies Commission; and

16 WHEREAS, he is a member of the First Baptist Church, the Valdosta Country Club, the Elks  
17 Club, and the Chamber of Commerce; and

18 WHEREAS, it is only fitting that Fred DeLoach, Jr., be honored for his many contributions  
19 to his state and community by having a road dedicated in his honor.

**PART IV**

21 WHEREAS, Charles Ray King was born in Waycross, Georgia, on March 27, 1949, the only  
22 son of Henry King, Jr., and Rosa Lee Turner King, and was a 1967 graduate of Ware County  
23 High School; and

24 WHEREAS, he lived in the Dixie Union area of Ware County where he worked on his  
25 father's farm; and

1 WHEREAS, he was drafted in 1969 and was sent to serve in Vietnam in 1970 where, on  
2 April 26, 1970, he was killed in action; and

3 WHEREAS, as a result of his gallantry and devotion to duty, he received the Bronze Star  
4 with an oak leaf cluster along with the Purple Heart, the Good Conduct Medal, the Combat  
5 Infantryman Badge, the National Defense Service Medal, the Vietnam Service Medal, and  
6 the Vietnam Campaign Medal; and

7 WHEREAS, he diligently and conscientiously devoted his time, talents, and energy toward  
8 the betterment of his community, state, and nation; and

9 WHEREAS, his significant organizational and leadership talents, his remarkable patience  
10 and diplomacy, his keen sense of vision, and his sensitivity to the needs of the citizens of his  
11 nation earned him the respect and admiration of his colleagues and associates; and

12 WHEREAS, he was a person of magnanimous strengths with an unimpeachable reputation  
13 for integrity, intelligence, fairness, and kindness, and it is only fitting and proper that the  
14 bridge over the Satilla River on State Route 4/U. S. Route 1 in Ware County should be  
15 named in his honor.

16 **PART V**

17 WHEREAS, Ottis L. Stonecypher, Sr., was born on February 8, 1930, at a private residence  
18 in Habersham County; he was the second of four children in his family; and

19 WHEREAS, he was raised on a farm in the Clarkesville-Mount Airy area and attended the  
20 Hills Switch School until he began his working life; and

21 WHEREAS, he had been married to Treelis Ward Stonecypher for almost 30 years at the  
22 time of his death and he had three children, five grandchildren, and two great-grandchildren;  
23 and

24 WHEREAS, he was killed in an automobile accident on May 13, 2002, while returning from  
25 a cattle sale; and

26 WHEREAS, Stonecypher's professional life was more than full, and he was known as many  
27 things to many people; he was a businessman, a farmer, a mentor, an advisor, a leader, a  
28 family man, and a friend; and

1 WHEREAS, at one point, he owned seven different Tastee-Freeze franchises all over  
2 Northeast Georgia; eventually he withdrew from the franchises and maintained two  
3 restaurants on his own, named Stoney's Family Restaurant, located in Clarkesville and  
4 Cleveland, Georgia; and

5 WHEREAS, Stoney was also an avid cattle farmer, averaging between 500 and 600 head of  
6 cattle at any given time, and particularly enjoyed this aspect of his life, joining several boards  
7 and committees related to farming; he was a board member with North Georgia Cattlemen's  
8 Association as well as the state-wide Georgia Cattlemen's Association, and he was on the  
9 Georgia Beef Board; and

10 WHEREAS, he won many awards during his life and after his death; the livestock pavilion  
11 at the Habersham County Fairgrounds was renamed and dedicated to Ottis Stonecypher, Sr.,  
12 for his lifelong commitment to farming and raising cattle; the Habersham County Farm  
13 Bureau building was renamed Ottis Stonecypher, Sr. Building, and they awarded him the  
14 Outstanding Dedication and Leadership Award; the Georgia Farm Bureau honored  
15 Stonecypher with the Lifelong Commitment Award; he also received the Georgia and  
16 Habersham County Farm Bureau Community Leader Award and the Upper Chattahoochee  
17 Farm Family of the Year Award; and

18 WHEREAS, he was always very community-minded, staying involved in most all aspects  
19 of the betterment of Habersham County life; he was chairman of the board at Habersham  
20 County Medical Center, president of Habersham County Farm Bureau, and sat on its board;  
21 and he was also a board member of Georgia Farm Bureau and Community Bank and Trust;  
22 and

23 WHEREAS, Stonecypher was in the Charter Class of Leadership Habersham and was a  
24 member of the Mountaineer Shrine Club and Yaarab Temple; he was involved in many  
25 aspects of North Georgia community life and was well respected in all he did; and

26 WHEREAS, he was a Korean War Veteran and is buried in the VFW Cemetery in Demorest,  
27 Georgia; and

28 WHEREAS, everyone Stonecypher knew, and those who knew him, respected and admired  
29 him as a determined, hard worker and a self-made man; a person would be hard-pressed to  
30 find someone that did not like Stoney, as he would help anyone in any way he could,  
31 throughout his life; his legacy is one of dedication and hard work, compassion and

1 generosity; he will be remembered as one of Northeast Georgia's finest citizens, and is  
2 greatly missed.

3 **PART VI**

4 WHEREAS, Sergeant Michael C. Hardegree was recently killed in a tragic accident while  
5 serving his country in Baghdad, Iraq; and

6 WHEREAS, Michael was a native of Villa Rica, Georgia, where he grew up loving music  
7 and golf and graduated from Villa Rica High School in 2004; and

8 WHEREAS, after graduation, he carried on a family tradition of military service by  
9 becoming an army paratrooper, serving with valor and distinction during two tours of duty  
10 in Iraq; and

11 WHEREAS, this noble young soldier served with selfless patriotism and brought great honor  
12 to himself, his family, and his community; and

13 WHEREAS, Sergeant Hardegree is survived by his parents, Stan and Cindy Hardegree of  
14 Villa Rica, and his sister, Beth Shaw of Fort Monroe, Virginia; and

15 WHEREAS, it is fitting that we pay tribute to this brave warrior.

16 **PART VII**

17 WHEREAS, Edwin Hamilton was a long-time resident of Emerson, Georgia; and

18 WHEREAS, he served his country in the Navy during World War II; and

19 WHEREAS, he managed the Colonial Food Store in Cartersville, Georgia, for many years;  
20 and

21 WHEREAS, he cooperated in allowing the acquisition of his homeplace for the construction  
22 of this road and bridge, even though he was displaced at a time in his life when relocating  
23 was very difficult for him and his wife; and

24 WHEREAS, Edwin Hamilton passed away in 2007 at the age of 86.

2 WHEREAS, Reverend George W. Nealy was born on October 15, 1929, and died on  
3 December 21, 2007; and

4 WHEREAS, he spent many years of his life fighting for civil rights and, most notably for  
5 Webster County, Georgia, was involved in bringing about legal action that resulted in the  
6 formation of a multimember county commission in 1990 that guaranteed African American  
7 representation on the governing body of the county; and

8 WHEREAS, without Reverend Nealy's invaluable contributions, Webster County would not  
9 have achieved the level of interracial cooperation in governmental affairs that exists today.

11 WHEREAS, Cliff Shannon was tragically killed in a motorcycle accident on  
12 September 17, 2004; and

13 WHEREAS, Cliff, who was born on December 1, 1956, served for nearly 30 years as a  
14 dedicated member of the Preston/Webster County Volunteer Fire Department; and

15 WHEREAS, his contribution and service to his community will always be remembered and  
16 his death has left a void that is yet to be filled.

18 WHEREAS, Glenn E. Taylor was born in Paulding County in 1922 and was raised within  
19 a 60 mile radius of his birthplace; and

20 WHEREAS, prior to his passing on May 1, 2006, he was a prominent citizen of Bartow  
21 County and the State of Georgia; and

22 WHEREAS, he was a well respected and successful businessman, having established several  
23 enterprises, including the Bankhead Welding Service, Bankhead Manufacturing Group, Inc.,  
24 and Bankhead Railway Services, Inc.; and

25 WHEREAS, Glenn E. Taylor was also well known for his support of many charitable and  
26 benevolent organizations and he often opened his home and farm to host a variety of  
27 charitable and worthwhile events, such as the Cartersville-Bartow County annual picnic and  
28 the Euharlee Farmers Barbeque; and

1 WHEREAS, he also set an example of unselfish public service while serving as past  
2 chairman and board member for the Georgia Department of Natural Resources for 23 years;  
3 and

4 WHEREAS, he had a deep love and respect for the land he farmed along SR 113 in Bartow  
5 County, and many prominent Georgians attended gatherings on his farm; and

6 WHEREAS, his most notable characteristic was his gentle nature and the kindness that he  
7 displayed in all aspects of his life; it can truly be said that to have known him was to have  
8 known a Southern Christian gentleman; and

9 WHEREAS, it is only fitting that a road be dedicated as a lasting monument to his  
10 contributions to the people of Bartow County and the State of Georgia.

11 **PART XI**

12 WHEREAS, William "Billy" L. Powell, Jr., began working with the Georgia Department of  
13 Transportation in 1963, and he worked his way up the ladder from engineering aide to  
14 transportation engineer II; and

15 WHEREAS, he retired in 1996 after 34 years of faithful service, after which he worked with  
16 CPI Construction Company and Zel Engineers; and

17 WHEREAS, his first love in life was his family, his dear wife, Mary Alice, and his two  
18 daughters, and they were always on his mind, and his second love was fishing; and

19 WHEREAS, Mr. Powell was tragically killed by an unknown gunman a few days before  
20 Thanksgiving, 2005; and

21 WHEREAS, he is remembered in his community as a man of strong family values and moral  
22 fiber.

23 **PART XII**

24 WHEREAS, Trey Bartlett was a member in the United States Armed Forces, and he was  
25 serving his country in Iraq on July 15, 2007, when he lost his life at the young age of 25; and

26 WHEREAS, Trey returned to military duty in Iraq after coming home at the time of his  
27 father's death; out of his dedication to serve our great country during this time of conflict,

1 he chose to return to duty at a time when he could have been honorably discharged, but he  
2 would not have it any other way; and

3 WHEREAS, Benjamin Blake Bartlett, Sr., Trey's father, passed away on April 13, 2007, at  
4 the age of 63; and

5 WHEREAS, Anna Ruth Lee Bartlett (Ann), Trey's mother, passed away on May 13, 1991,  
6 at the age of 47, when Trey was only nine years old; and

7 WHEREAS, Trey's only sibling, his sister, Lura Lee Bartlett, passed away on  
8 September 23, 1997, at the age of 31; and

9 WHEREAS, prior to enlisting in the military, Trey resided in Talbot County, Georgia, with  
10 his father on the family homestead that is located on SR 41 between Woodland and  
11 Manchester, Georgia; and

12 WHEREAS, it is only fitting that this young soldier have a road dedicated in his honor to  
13 serve as a lasting tribute of his service to his state and his country.

15 WHEREAS, Leonard R. "Nookie" Meadows was born December 8, 1926, in Meriwether  
16 County, Georgia; he was the son of James Alvin and Mozelle Wise Meadows; and

17 WHEREAS, he was a lifelong resident of Manchester, Georgia, and retired after a successful  
18 career as the president of the Meadows Companies, which included Meadows Motors, Inc.,  
19 Meadows Ford, Inc., Meadows Insurance Agency, Smith-Steele Meadows Funeral Home,  
20 and Meadows Farms; and

21 WHEREAS, for most of his life, Nookie took an active interest in his community and its  
22 citizens, relentlessly volunteering his time and energy so that others might experience a better  
23 quality of life, and he built a viable business network that provided local employment and  
24 stimulated economic growth that benefited the lives of many people throughout the  
25 community and state; and

26 WHEREAS, he served as Representative of House District 91 from 1987 until 1992; and

1 WHEREAS, he was a member of the National Automobile Dealers Association, the Georgia  
2 State University Foundation Fund, and the Columbus Bank and Trust Advisory Board; a past  
3 president of the Manchester Industrial Corporation; a member of the Meriwether County  
4 Chamber of Commerce; a past president of the Kiwanis Club, where he held perfect  
5 attendance for 43 years; a member of the committee to save the Georgia Warm Springs  
6 Foundation, now the RWSIR; chairman and chairman emeritus of the Roosevelt Warm  
7 Springs Rehabilitation Fund from 1986 to 1992; a past president of the Roosevelt Warm  
8 Springs Development Fund; a past president of the Manchester Jaycees; a member of the  
9 Stephens Lodge #586 of the Free and Accepted Masons, the AL Sihah Shrine Temple, the  
10 Elks Lodge, the Moose Lodge, the American Legion, and the Pontiac Masters; a recipient  
11 of the Chevrolet Supremacy for over 22 years, the Honorary State Trooper award, the Flying  
12 Colonel award, the Manchester Chamber of Commerce Community Service Award, and the  
13 James T. Evans Rotary Award for Community Service; a member of the Manchester School  
14 Board, the Advisory Board of the Bank of Upson, and the Georgia Baptist Meriwether  
15 Hospital and Nursing Home Board; and he spearheaded the relocation of Horizon Medical  
16 to Manchester; and

17 WHEREAS, it is only fitting and proper to celebrate the life of this Georgian and to  
18 recognize his great contributions to this state and to his community by dedicating the  
19 Leonard R. "Nookie" Meadows Memorial Highway in his memory.

21 WHEREAS, Franklin Lee Dixon passed away on September 14, 2007; and

22 WHEREAS, it is the desire of the Rabun County Department of Education to honor Franklin  
23 Lee Dixon for his distinguished service to the citizens of Clayton and Rabun County; and

24 WHEREAS, Franklin Lee Dixon was born in Fannin County, Georgia, and was the son of  
25 the late Bruce Burrell Dixon and Laura Freeman Dixon; and

26 WHEREAS, Franklin Lee Dixon is survived by his wife, Joyce Ann Simmons Dixon; a son,  
27 Adam Dixon, and his wife, Jodi, of Clayton, Georgia; and three daughters, Dawn Shaw and  
28 her husband, Lee, of Flowery Branch, Georgia, Tara York and her husband, Bryne, of Tiger,

30 WHEREAS, also surviving is one brother, Benjamin Bruce Dixon, of Dawsonville, Georgia,  
31 and ten grandchildren, Daniel C. Ramey, Jared Shaw, Connor Shaw, Anna Kate Shaw,

1 O'Neil York, MacKenzie York, Keldon Dixon, Clayton Hunter Dixon, Abby Thompson, and  
2 Marley Thompson; and

3 WHEREAS, Franklin Lee Dixon was the Transportation Director for the Rabun County  
4 School System, and for 30 years, he drove Rabun County students to school and for many  
5 extracurricular activities and was active in the Athletic Booster Club where he filmed  
6 football games for many years, and he always took pride in all of the children of Rabun  
7 County, Georgia; and

8 WHEREAS, Franklin Lee Dixon took a special interest in caring for and assisting children  
9 with learning disabilities and never failed to conscientiously accept every driving assignment  
10 requested of him; and

11 WHEREAS, he was a member of Flat Creek Baptist Church, a Master Mason and member  
12 of Blue Mountain Lodge #38, and a veteran of the United States Army Reserve; and

13 WHEREAS, it is only right that this man's fruitful life be celebrated as he makes his home  
14 in heaven.

17 Rabun County High School in 1983 and immediately went to work for the City of Clayton

1 generally southward, and thence generally southwestward to the intersection of said route  
2 with Madison Highway is dedicated as Veterans Memorial Parkway.

3 BE IT FURTHER RESOLVED that the portion of SR 94 from Perimeter Road in Lowndes  
4 County, Georgia, to the Echols County line is dedicated as the Fred DeLoach, Jr. Highway.

5 BE IT FURTHER RESOLVED that the bridge over the Satilla River on State Route 4/U. S.  
6 Route 1 in Ware County is dedicated as the Charles Ray King Memorial Bridge.

7 BE IT FURTHER RESOLVED that a portion of SR 197 from Mt. Airy to its intersection  
8 with SR 17, in Habersham County, be dedicated as the Ottis L. Stonecypher, Sr. Memorial  
9 Highway.

10 BE IT FURTHER RESOLVED that the portion of SR 101 from the Carroll-Paulding County  
11 line to the intersection with Industrial Boulevard, in Carroll County, Georgia, be dedicated  
12 as the Sergeant Michael C. Hardegree Memorial Highway.

13 BE IT FURTHER RESOLVED that the members of this body dedicate the new bridge on  
14 SR 296 at SR 113, in Bartow County, as the Edwin Price Hamilton Memorial Bridge.

15 BE IT FURTHER RESOLVED that the bridge on SR 41 over Kinchafoonee Creek, in  
16 Webster County, be dedicated as the Reverend George W. Nealy Memorial Bridge in his  
17 honor.

18 BE IT FURTHER RESOLVED that the members of this body dedicate the bridge on SR 153  
19 over Lanahassee Creek, in Webster County, as the Cliff Shannon Memorial Bridge in honor  
20 of his service to his community.

21 BE IT FURTHER RESOLVED that the portion of SR 113 from the Polk County line to Red  
22 Top Mountain Road at I-75, in Bartow County, be named the Glenn E. Taylor Memorial  
23 Parkway.

24 BE IT FURTHER RESOLVED that State Route 104 in Richmond County is dedicated as the  
25 William "Billy" L. Powell, Jr., Highway.

1 BE IT FURTHER RESOLVED that the portion of SR 41 from the northern city limits of  
2 Woodland, Georgia, to the southern city limits of Manchester, Georgia, in Talbot County be  
3 dedicated as the SFC Benjamin "Trey" Blake Bartlett Jr. Memorial Highway.

4 BE IT FURTHER RESOLVED that the portion of SR 85 East between Manchester and  
5 Woodbury in Meriwether County, Georgia, be dedicated as the Leonard R. "Nookie"  
6 Meadows Memorial Highway.

7 BE IT FURTHER RESOLVED that the bridge on US 441 near Rabun County High School  
8 in Rabun County be dedicated as the Lee Dixon Memorial Bridge in memory of his service  
9 to the people of Rabun County and the State of Georgia.

10 BE IT FURTHER RESOLVED that the portion of SR 15/US 441 within the Clayton City  
11 limits in Rabun County be dedicated as the Trooper Michael R. Fortson Memorial Highway.

12 BE IT FURTHER RESOLVED that the westbound lane of the easternmost bridge crossing  
13 the Alapaha River on Highway 82 in Atkinson County be dedicated as the Corporal William  
14 "Billy" Harvey Jewell, Sr. Bridge in his honor.

15 BE IT FURTHER RESOLVED that the portion of SR 243 between SR 57 at the  
16 Twiggs-Wilkinson County line and SR 24 in Baldwin County be dedicated as the Veterans  
17 Memorial Highway.

18 BE IT FURTHER RESOLVED that the Department of Transportation is authorized and  
19 directed to erect and maintain appropriate signs dedicating the road facilities named in this  
20 resolution.

21 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized  
22 and directed to transmit appropriate copies of this resolution to the Department of  
23 Transportation, to the family of Sheriff D. J. Connell, to Fred DeLoach, Jr., to the family of  
24 Charles Ray King, to the family of Ottis L. Stonecypher, Sr., to the family of Sergeant  
25 Michael C. Hardegree, to the family of Edwin Price Hamilton, to the family of Reverend  
26 George W. Nealy, to the family of Cliff Shannon, to the family of Glenn E. Taylor, to the  
27 family of William "Billy" L. Powell, Jr., to the family of Benjamin Blake Bartlett, Jr., to the
