6 WHEREAS, he continued his career with the State Patrol, being promoted to Corporal in 7 1982; to Sergeant in 1983; to Sergeant First Class in 1986, assigned as Post Commander of 8 Post 8 in Madison, Georgia; to Lieutenant in 1992, assigned to serve as Assistant Troop Commander in Troop H; to Captain in 1999, assigned to serve as Troop I Commander, later 9 transferring to serve as Troop E Commander; to Major in 2003, serving as North Division 10 11 Adjutant; to Commanding Officer of the Georgia State Patrol in 2005, overseeing the Field 12 Operations, Aviation, SWAT, and SCRT; and in 2007, he was named Deputy Commissioner 13 of the Department of Public Safety, overseeing the command of the Field Operations, 14 Support Services, Capitol Police Services, and Motor Carrier Compliance Divisions; and

15 WHEREAS, his professional accomplishments include graduating from Georgia Southern 16 University with a Bachelor of Science in Criminal Justice, graduating from Columbus State 17 University with a Master of Public Administration, attending the 165th FBI National Academy, graduating from the Georgia Law Enforcement Command College, attending the 18 19 Georgia International Law Enforcement Exchange Program with Israel, and receiving 20 Department Valor, Lifesaving, and Purple Heart awards, and he has served as an original 21 member of the Georgia State Patrol SWAT Team and as SWAT Team Leader from 1989 22 through 1994; and

WHEREAS, Lieutenant Colonel Chastain has balanced his career with community activities,
serving as an active member and Sunday school teacher at First Baptist Church of Social
Circle, participating in mission work in West Virginia, volunteering at Camp Twin Lakes,

- 2 many young men to the saving knowledge of Christ; and
- WHEREAS, he is devoted to his wife Hollie, children Scott, Derek, and Heather, andgrandchildren Haley and Will; and
- 5 WHEREAS, throughout his exemplary career, Lieutenant Colonel Don Chastain served as 6 a loyal and dedicated trooper known for his leadership, integrity, work ethic, and 7 compassion; and
- 8 WHEREAS, committed to the mission of the Department of Public Safety, he has worked9 tirelessly above and beyond the call of duty.
