Senate Resolution 1202

A RESOLUTION

- 1 Urging the Surgeon General of the Army and the Chief, National Guard Bureau to change
- 2 existing policy regarding the ability of priority units within the National Guard, who have
- 3 a high probability of future deployment into a combat zone, to receive Warfighter Refractive
- 4 Eye Surgery Program (WRESP) benefits; and for other purposes.
- 5 WHEREAS, the Chief of Staff of the Army has written that "soldiers performing duties in
- 6 adverse conditions, often without timely optical fabrication support, will find the lack of
- 7 dependence on corrective lenses an invaluable asset in the confident execution of their
- 8 mission"; and
- 9 WHEREAS, the Chief of Staff of the Army has also written that the WRESP program "offers
- 10 soldiers access to corrective eye surgery and provides commanders with an important
- 11 medical resource for the enhancement of soldier readiness"; and
- 12 WHEREAS, the criteria under WRESP for selecting soldiers for laser eye correction gives
- priority to special operations and combat arms units such as infantry, field artillery, and
- 14 armor battalions, as well as units whose mission involves operations at the time of battle or
- 15 behind hostile lines; and
- 16 WHEREAS, the criteria for selecting soldiers for laser eye correction provides that nonactive
- duty personnel are not authorized treatment under the program, requires that a soldier must
- have at least 18 months remaining on active duty at the time of surgery, and mandates that
- 19 treated individuals must return for follow-up visits as specified postoperatively in the
- 20 applicable protocol as a condition of treatment; and
- 21 WHEREAS, the WRESP criteria provides for conflict with regard to the existence of soldiers
- 22 within the National Guard who fall under the WRESP criteria as priority units yet fail to meet
- 23 the criteria for time remaining on active duty, as National Guard soldiers typically spend 365
- 24 days on active duty; and

1 WHEREAS, priority units within the National Guard who are called to active duty are asked

- 2 to perform the same tasks and duties as their full-time active duty counterparts yet are unable
- 3 to participate in WRESP and therefore are at risk of being unable to perform their duties as
- 4 effectively or as safely as their full-time active duty counterparts; and
- 5 WHEREAS, Department of Defense regulations require a minimum of 90 days to notify
- 6 National Guard units of alert to active duty, and WRESP regulations require a 90 day
- 7 recovery period following corrective surgery, and this conflict of scheduling hinders the
- 8 ability of WRESP priority units within the National Guard to receive corrective eye surgery;
- 9 and
- 10 WHEREAS, the Army should consider corrective eye surgery under WRESP to be a vital
- 11 part of adequately preparing soldiers for combat duty, just as pre-deployment training is, and,
- 12 just as is done for pre-deployment training, should set aside time for corrective eye surgery
- 13 to be completed; and
- 14 WHEREAS, just as combat training schools set aside a percentage of placements in their
- 15 courses for National Guard soldiers, a percentage of surgical slots for corrective laser eye
- 16 surgery under WRESP should be set aside for National Guard soldiers; and
- 17 WHEREAS, questions of priority and time are recognized, and therefore, the following
- 18 actions should be pursued: classification as a "priority" unit in terms of eligibility for
- 19 WRESP should be based upon the actual role of the unit in a combat zone rather than the
- 20 unit's status as active duty or National Guard; identification of priority (i.e. Special
- 21 Operations) units within the National Guard who have a high probability of being called to
- 22 active duty and scheduled for rotation be carried out by establishing an allotment of a
- 23 minimum of six months prior to highly probable deployment for such units to ensure
- 24 adequate time for postoperative recovery and required checkups and notification of active
- 25 duty alert; and
- 26 WHEREAS, the ongoing War in Iraq has taken a significant toll on the National Guard, and
- 27 providing benefits for priority units within it will aid in its continuing mission in the Middle
- 28 East; and
- 29 WHEREAS, if the aforementioned actions are taken, all units, whether full-time active duty
- 30 or National Guard, who can be classified as priority units will be adequately prepared to

1 effectively and safely carry out their duties and advance the mission of the United States

- 2 Army in the ongoing Global War on Terror.
- 3 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
- 4 urge the Surgeon General of the Army and the Chief, National Guard Bureau to change
- 5 existing regulations to enable priority units within the National Guard, for whom a call to
- 6 active duty is highly probable, to receive corrective laser eye surgery under WRESP.
- 7 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed
- 8 to transmit appropriate copies of this resolution to each member of the Georgia congressional
- 9 delegation; the Secretary of Defense; and the Chief, National Guard Bureau.
