

The House Committee on Regulated Industries offers the following substitute to SB 498:

A BILL TO BE ENTITLED
AN ACT

1 To amend Article 9 of Chapter 34 of Title 43 of the Official Code of Georgia Annotated,
2 relating to cosmetic laser services, so as to change certain provisions relating to the licensing
3 of cosmetic laser practitioners to revise and add a definition; to require that each patient be
4 examined prior to any cosmetic laser service being performed; to require that each facility
5 offering cosmetic laser services have a supervisor; to provide certain qualifications and
6 responsibilities for supervisors; to require that certain information regarding cosmetic laser
7 practitioners, supervisors, and consulting physicians be disclosed by the facilities; to allow
8 the Composite State Board of Medical Examiners to waive certain provisions of Article 9;
9 to provide for a licensed physician to be a member of the advisory board; to provide for
10 related matters; to provide for a contingent effective date; to repeal conflicting laws; and for
11 other purposes.

12 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

13 style="text-align:center">**SECTION 1.**

14 Article 9 of Chapter 34 of Title 43 of the Official Code of Georgia Annotated, relating to
15 cosmetic laser services, is amended by revising Code Section 43-34-242, relating to
16 definitions, as follows:

17 "43-34-242.

18 As used in this article, the term:

19 (1) 'Board' means the Composite State Board of Medical Examiners created by Code
20 Section 43-34-21.

21 (2) 'Consulting physician' means a ~~person licensed to practice medicine under this~~
22 ~~chapter and~~ physician:

23 (A) Whose principal place of practice is within this state; or

24 (B) Whose principal place of practice is outside this state but is within 50 miles from
25 the facility with whom he or she has an agreement to provide services in accordance
26 with Code Section 43-34-248.

- 1 (3) 'Consumer' means a person on whom cosmetic laser services are or are to be
2 performed.
- 3 (4) 'Cosmetic laser practitioner' means a person licensed under this article to provide
4 cosmetic laser services as defined in this article and whose license is in good standing.
- 5 (5) 'Cosmetic laser services' means nonablative elective cosmetic light based skin, photo
6 rejuvenation, or hair removal using lasers and pulsed light devices approved by the
7 United States Food and Drug Administration for noninvasive procedures. Such services
8 and the provision thereof shall not be considered to be the practice of medicine.
- 9 (6) 'Facility' means any location, place, area, structure, office, institution, or business or
10 a part thereof in which is performed or provided cosmetic laser services regardless of
11 whether a fee is charged for such services.
- 12 (7) 'License' means a valid and current certificate of registration issued by the board
13 which shall give the person to whom it is issued authority to engage in the practice
14 prescribed thereon.
- 15 (8) 'Licensee' means any person holding a license under this article.
- 16 (9) 'Medical practitioner' means a registered professional nurse, licensed practical nurse,
17 nurse practitioner, physician's assistant, or physician.
- 18 (10) 'Nurse' means a registered professional nurse, licensed practical nurse, or nurse
19 practitioner.
- 20 (11) 'Person' means a natural person.
- 21 (12) 'Physician' means an individual who is licensed to practice medicine under Article
22 2 of Chapter 34 of this title."

23 **SECTION 2.**

24 Said article is further amended by revising Code Section 43-34-244, relating to two levels
25 of license and applications, as follows:

26 "43-34-244.

27 (a) There shall be two levels of a license for a cosmetic laser practitioner: assistant laser
28 practitioner and senior laser practitioner.

29 (b) Any person desiring to obtain a license as a cosmetic laser practitioner under the terms
30 of this article shall make application to the board as follows:

31 (1) An applicant for an 'assistant laser practitioner' license shall present proof that he or
32 she:

33 (A) Holds a current valid license or certificate of registration as a physician's assistant,
34 nurse, esthetician, or master cosmetologist, or has previously held a license or
35 certificate of registration as a medical practitioner; and

1 (B) Has received at least three laser certificates from attending laser/intense pulsed
 2 light (IPL) courses as approved by the board, directly taught by a licensed physician or
 3 certified continuing medical education or continuing education educator.

4 If, after review of the application, it is determined that the applicant is at least 21 years
 5 of age; has met the minimum educational requirements; is of good moral character; and
 6 is possessed of the requisite skill to perform properly cosmetic laser services, a license
 7 shall be issued to the applicant entitling the applicant to practice the occupation of
 8 cosmetic laser practitioner at the assistant laser practitioner level under the ~~direct~~ on-site
 9 supervision of a senior laser practitioner.

10 (2) An applicant for a 'senior laser practitioner' license shall present proof that he or she:

11 (A) Holds a current valid license or certificate of registration as a physician's assistant
 12 or nurse or has previously held a license or certificate of registration as a medical
 13 practitioner;

14 (B) Has at least three years of clinical or technological medical experience, or both;

15 (C) Has been or was licensed or nationally board certified as a medical practitioner for
 16 at least three years; and

17 (D) Has received at least two laser certificates from attending laser/intense pulsed light
 18 (IPL) continuing medical education courses as approved by the board, directly taught
 19 by a licensed physician or certified continuing medical education or continuing
 20 education educator.

21 If, after review of the application, it is determined that the applicant is at least 21 years
 22 of age; has met the minimum educational and clinical training requirements to perform
 23 cosmetic laser services with indirect supervision; is of good moral character; and is
 24 possessed of the requisite skill to perform properly these services, a license shall be
 25 issued to the applicant entitling the applicant to practice the occupation of cosmetic laser
 26 practitioner at the senior laser practitioner level pursuant to the protocols of a consulting
 27 physician.

28 ~~(c) The board shall be authorized to waive any education requirements under this Code~~
 29 ~~section in cases of hardship, disability, or illness or under such other circumstances as the~~
 30 ~~board deems appropriate with respect to any applicant who has practiced as a cosmetic~~
 31 ~~laser practitioner prior to July 1, 2007.~~

32 (c) Any person desiring to obtain a license as an 'assistant laser practitioner' who does not
 33 meet the requirements of paragraph (1) of subsection (b) of this Code section shall also be
 34 eligible for a license as an 'assistant laser practitioner' if he or she makes application to the
 35 board within six months of the effective date of this article and presents proof that he or
 36 she:

1 (1) Prior to the effective date of this article, obtained a minimum of at least 2,000 hours
 2 of experience in administering cosmetic laser service; and

3 (2) Has received at least three laser certificates from attending laser/intense pulsed light
 4 (IPL) courses, directly taught by a licensed physician or certified continuing medical
 5 education or continuing education educator.

6 (d) Should an applicant have a current cosmetic laser practitioner license or certificate of
 7 registration in force from another state, country, territory of the United States, or the
 8 District of Columbia, where similar reciprocity is extended to this state and licensure
 9 requirements are substantially equal to those in this state, and have paid a fee and have
 10 submitted an application, the applicant may be issued a license at the appropriate level
 11 entitling him or her to practice the occupation of a cosmetic laser practitioner at that level,
 12 unless the board, in its discretion, sees fit to require a written or a practical examination
 13 subject to the terms and provisions of this article. ~~The board shall be authorized to waive~~
 14 ~~any education or experience requirements applicable to any person who holds a current~~
 15 ~~license or certificate to practice as a cosmetic laser practitioner outside of this state and~~
 16 ~~who desires to obtain a license at a level authorized under this Code section to practice as~~
 17 ~~a cosmetic laser practitioner in this state in cases of hardship, disability, or illness or under~~
 18 ~~such other circumstances as the board deems appropriate."~~

19 SECTION 3.

20 Said article is further amended by revising Code Section 43-34-248, relating to agreement
 21 with consulting physician, as follows:

22 "43-34-248.

23 (a) Any facility providing cosmetic laser services shall have an agreement with a
 24 consulting physician who shall:

25 (1) Be trained in laser modalities;

26 (2) Establish proper protocols for the cosmetic laser services provided at the facility and
 27 file such protocols with the board; and

28 (3) Examine each patient prior to any cosmetic laser service being performed; provided,
 29 however, that a consulting physician may delegate the authority to perform such
 30 examination to a physician's assistant, who is a licensed cosmetic laser practitioner, in
 31 accordance with a job description approved by the board or to a registered professional
 32 nurse, who is also an advanced practice registered nurse as defined in paragraph (1.1) of
 33 Code Section 43-26-3 and who is a licensed cosmetic laser practitioner, pursuant to a
 34 protocol approved by the board; and

35 ~~(3)~~(4) Be available for emergency consultation with the cosmetic laser practitioner or
 36 anyone employed by the facility.

1 (b) Any facility providing cosmetic laser services shall have a supervisor present at the
 2 facility at all times. The supervisor shall supervise the performance of all cosmetic laser
 3 services performed by a person other than the consulting physician. The supervisor shall
 4 be a physician licensed under this chapter who is trained in laser modalities or a senior
 5 laser practitioner.

6 (c)(1) Any facility providing cosmetic laser services shall post a sign listing the
 7 consulting physician's name, emergency contact number, his or her board certification
 8 and specialty, and the address of his or her principal place of practice, and indicating
 9 whether he or she is presently on site at the facility.

10 (2) If the consulting physician is not on site for any period of time during which the
 11 facility is open, the facility shall post a sign indicating who is presently acting as the
 12 supervisor for the facility and that person's name, emergency contact number, his or her
 13 degrees and qualifications, and the type of cosmetic laser practitioner license held."

14 SECTION 4.

15 Said article is further amended by revising Code Section 43-34-249, relating to informed
 16 consent, as follows:

17 "43-34-249.

18 (a) Prior to receiving cosmetic laser services from a cosmetic laser practitioner, a person
 19 must consent in writing to such services and shall be informed in writing of the general
 20 terms of the following:

21 (1) The nature and purpose of such proposed procedure;

22 (2) Any material risks generally recognized and associated with the cosmetic laser
 23 service to be performed which, if disclosed to a reasonably prudent person in the
 24 customer's position, could reasonably be expected to cause such prudent person to
 25 decline such proposed cosmetic laser services on the basis of the material risk of injury
 26 that could result from such proposed services;

27 (3) The name of, the degrees and qualifications held by, and type of license licenses
 28 obtained by the individual who will be performing the cosmetic laser service ~~has~~
 29 ~~obtained, the supervisor, and the consulting physician; and~~

30 (4) The steps to be followed after the cosmetic laser service is performed in the event of
 31 any complications; and

32 (5) The emergency contact information for the consulting physician and the address of
 33 his or her principal place of practice.

34 (a.1) After receiving each cosmetic laser service, a person shall be informed in writing of
 35 the information required by paragraphs (4) and (5) of subsection (a) of this Code section.

1 (b) It shall be the responsibility of the cosmetic laser practitioner to ensure that the
 2 information required by ~~subsection (a)~~ subsections (a) and (a.1) of this Code section is
 3 disclosed and that the consent provided for in this Code section is obtained.

4 (c) Where the consumer is under 18 years of age, the consent of the consumer's parent or
 5 legal guardian shall be required.

6 (d) The board shall be required to adopt and have the authority to promulgate rules and
 7 regulations governing and establishing the standards necessary to implement this Code
 8 section specifically including but not limited to the disciplining of a cosmetic laser
 9 practitioner who fails to comply with this Code section.

10 (e) Nothing in this Code section shall prohibit the information provided for in this Code
 11 section from being disclosed through the use of video tapes, audio tapes, pamphlets,
 12 booklets, or other means of communication or through conversations with the cosmetic
 13 laser practitioner; provided, however, that such information is also provided in writing and
 14 attached to the consent form which the consumer signs."

15 **SECTION 5.**

16 Said article is further amended by adding a new Code section to read as follows:

17 "43-34-249.1.

18 The board shall have the authority to waive the requirements of subsection (c) of Code
 19 Section 43-34-248 and paragraph (5) of subsection (a) of Code Section 43-34-249 for
 20 facilities offering cosmetic laser services which serve as the principal place of practice at
 21 which a physician regularly sees patients if medical services are regularly performed at
 22 such facilities. For purposes of this Code section, 'medical services' shall mean the general
 23 and usual services and care rendered and administered by a physician."

24 **SECTION 6.**

25 Said article is further amended by revising Code Section 43-34-250, relating to the advisory
 26 committee, as follows:

27 "43-34-250.

28 The board shall appoint an advisory committee. The advisory committee shall be
 29 representative of a cross section of the cultural backgrounds, to the extent practical, of the
 30 licensed cosmetic laser practitioners licensed under this article and such members as the
 31 board in its discretion may determine. The advisory committee shall include at least one
 32 person licensed to practice medicine under this chapter. Members shall receive no
 33 compensation for service on the committee. The committee shall have such advisory duties
 34 and responsibilities as the board may determine, including but not limited to consulting
 35 with the board on the issuance, denial, suspension, and revocation of licenses and the

1 promulgation of rules and regulations under this article. The initial members of the
2 advisory committee may include persons eligible for licensing under this article.
3 Subsequent advisory committee members must be licensed pursuant to this article."

4 **SECTION 7.**

5 This Act shall become effective only if and when the "Georgia Cosmetic Laser Services
6 Act," approved May 29, 2007 (Ga. L. 2007, p. 626), becomes effective as provided in
7 Section 2 therein.

8 **SECTION 8.**

9 All laws and parts of laws in conflict with this Act are repealed.
