- 17 Church, and he served on the board of directors for Freedom Counseling, a local drug
- 18 addiction rehabilitation facility; and
- 19 WHEREAS, he was actively involved in building two houses to be used as residential
- 20 recovery houses for Freedom Counseling and was working to build dream homes in the
