A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act providing an exemption from Catoosa County ad valorem taxes for county

- 12 Each resident of Catoosa County who is totally disabled and whose net income for the
- immediately preceding taxable year does not exceed \$20,000.00 is granted an exemption for
- 14 up to \$75,000.00 of the value of that person's homestead from all Catoosa County ad
- valorem taxes for county purposes."
- SECTION 2.
- 17 Unless prohibited by the federal Voting Rights Act of 1965, as amended, the election
- superintendent of Catoosa County shall call and conduct an election as provided in this
- 19 section for the purpose of submitting this Act to the electors of Catoosa County for approval
- 20 or rejection. The election superintendent shall conduct that election on the date of the
- 21 November, 2008, state-wide general election and shall issue the call and conduct that election
- as provided by general law. The superintendent shall cause the date and purpose of the
- 23 election to be published once a week for two weeks immediately preceding the date thereof
