## House Bill 1243 (AS PASSED HOUSE AND SENATE)

## A BILL TO BE ENTITLED AN ACT

- 1 To amend Article 1 of Chapter 9 of Title 3 of the Official Code of Georgia Annotated,
- 2 relating to sale of alcoholic beverages by public carriers and nonprofit organizations, so as
- 3 to change certain provisions relating to the issuance of temporary permits for sale of
- 4 alcoholic beverages by nonprofit organizations; to increase the number of days and number
- 5 of permits that the commissioner may issue; to increase fees for temporary permits; to
- 6 provide for nonprofit organizations to conduct auctions of wine donated by certain persons
- 7 under certain circumstances; to provide for procedure; to define a term; to provide for an
- 8 effective date; to provide for related matters; to repeal conflicting laws; and for other
- 9 purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

- 12 Article 1 of Chapter 9 of Title 3 of the Official Code of Georgia Annotated, relating to sale
- of alcoholic beverages by public carriers and nonprofit organizations, is amended by revising
- 14 Code Section 3-9-3, relating to issuance of temporary permits for sale by nonprofit civic
- organizations of alcoholic beverages for consumption only on premises, as follows:
- 16 "3-9-3.
- 17 (a) Upon the filing of an application and payment of a fee of \$25.00 by a bona fide
- 18 nonprofit civic organization, the commissioner may issue a permit authorizing the
- organization to sell alcoholic beverages for consumption only on the premises or to sell
- 20 <u>wine at retail for off-premises consumption, or both,</u> for a period not to exceed <del>one day</del>
- 21 <u>three days</u>, subject to any law regulating the time for selling such beverages.
- 22 (b) No more than two six permits may be issued to an organization in any one calendar
- year pursuant to this Code section.
- 24 (c) Permits issued pursuant to this Code section shall be valid only for the place specified
- in the permit. No permit may be issued unless the sale of distilled spirits, wine, or malt
- beverages is lawful in the place for which the permit is issued."

## SECTION 2.

- 2 Said article is further amended by adding two new Code sections to read as follows:
- 3 "3-9-4.
- 4 (a) Upon the filing of an application and payment of a fee of \$25.00 by a bona fide
- 5 nonprofit civic organization, the commissioner may issue a special use temporary permit
- 6 authorizing a bona fide nonprofit civic organization to auction wine in sealed containers
- 7 only for a period not to exceed three days, subject to any law regulating the time for selling
- 8 wine.
- 9 (b) No more than six special use temporary permits may be issued to a bona fide nonprofit
- 10 civic organization in any calendar year.
- 11 (c) Special use temporary permits issued pursuant to this Code section shall be valid only
- for the location specified in the permit. No special use temporary permit may be issued
- unless local licensing authorities have issued to the bona fide nonprofit civic organization
- a permit or approval for the sale of wine at the location specified in the special use
- 15 temporary permit. Prior to the commencement of the event described in the special use
- 16 temporary permit, the bona fide nonprofit civic organization shall furnish to the
- 17 commissioner a detailed inventory list of the wine to be auctioned including:
- 18 (1) The name, address, telephone number, and taxpayer identification number of the
- 19 person who furnishes the wine for the event; and
- 20 (2) The type, brand, label, and quantity of each wine to be sold at auction.
- 21 (d) Bona fide nonprofit civic organizations which hold a special use temporary permit
- issued pursuant to this Code section may auction for off-premises consumption wine in
- sealed containers, which has been donated to the bona fide nonprofit civic organization by
- a person who does not currently hold a license that has been issued by the department
- 25 pursuant to this title, wine which has been donated by a Georgia licensed retailer, or wine
- 26 which has been donated or purchased from a Georgia licensed wine wholesaler. The bona
- 27 fide nonprofit civic organization may ship or otherwise transport to the location specified
- in the special use temporary permit wine donated by a person who does not currently hold
- a license that has been issued by the department pursuant to this title or wine donated by
- 30 a Georgia licensed retailer. Georgia excise tax shall be paid to the department on any
- donated wine. If the bona fide nonprofit civic organization cannot verify, within ten days
- 32 of the conclusion of the permitted event, that Georgia excise tax for the wine was
- previously paid to the department, the bona fide nonprofit civic organization shall pay to
- 34 the department the appropriate excise tax as required by law.

- 2 As used in this article, the term 'bona fide nonprofit civic organization' means an entity
- 3 which is exempt from federal income tax pursuant to the provisions of 26 U.S.C. Sections
- 4 501(c), 501(d), or 501(e)."
- 5 SECTION 3.
- 6 This Act shall become effective upon its approval by the Governor or upon its becoming law
- 7 without such approval.
- 8 SECTION 4.
- 9 All laws and parts of laws in conflict with this Act are repealed.
