A BILL TO BE ENTITLED AN ACT

- 1 To authorize Gwinnett County to exercise all redevelopment and other powers under Article
- 2 IX, Section II, Paragraph VII(b) of the Constitution and Chapter 44 of Title 36 of the
- 3 O.C.G.A., the "Redevelopment Powers Law," as amended; to provide for a referendum; to
- 4 provide effective dates; to provide for automatic repeal under certain circumstances; to repeal
- 5 conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

- 8 Gwinnett County shall be and is authorized to exercise all redevelopment and other powers
- 9 under Chapter 44 of Title 36 of the O.C.G.A., the "Redevelopment Powers Law," as
- 10 amended. The intention of this Act is to authorize Gwinnett County to undertake and carry
- out community redevelopment, to create tax allocation districts, to issue tax allocation bonds,
- 12 and to incur other obligations within the meaning of and as fully permitted under the
- provisions of Article IX, Section II, Paragraph VII(b) of the Constitution of the State of
- 14 Georgia of 1983, as amended, and to authorize Gwinnett County to exercise redevelopment
- powers as fully as the "Redevelopment Powers Law" may now or hereafter permit and not
- 16 to limit any redevelopment powers permitted under the "Redevelopment Powers Law."

17 SECTION 2.

- 18 Unless prohibited by the federal Voting Rights Act of 1965, as amended, the election
- 19 superintendent of Gwinnett County shall call and conduct an election as provided in this
- 20 section for the purpose of submitting this Act to the electors of Gwinnett County for approval
- 21 or rejection. The election superintendent shall conduct that election on the earliest practical
- date under Code Section 21-2-540 of the O.C.G.A. and shall issue the call and conduct that
- 23 election as provided by general law. The superintendent shall cause the date and purpose of
- 24 the election to be published once a week for two weeks immediately preceding the date

1 thereof in the official organ of Gwinnett County. The ballot shall have written or printed

- 2 thereon the words:
- 3 "() YES Shall the Act be approved which authorizes Gwinnett County to exercise
- 4 redevelopment powers under the 'Redevelopment Powers Law,' as it may
- 5 () NO be amended from time to time, for the purpose of improving economic and social conditions in depressed areas within the county?"
- 7 All persons desiring to vote for approval of the Act shall vote "Yes," and all persons desiring
- 8 to vote for rejection of the Act shall vote "No." If more than one-half of the votes cast on
- 9 such question are for approval of the Act, then Section 1 of this Act shall become of full
- 10 force and effect immediately. If Section 1 of this Act is not so approved or if the election is
- 11 not conducted as provided in this section, Section 1 of this Act shall not become effective
- 12 and this Act shall be automatically repealed on the first day of January immediately
- 13 following that election date. The expense of such election shall be borne by Gwinnett
- 14 County. It shall be the election superintendent's duty to certify the result thereof to the
- 15 Secretary of State.

SECTION 3.

- 17 Except as otherwise provided in Section 2 of this Act, this Act shall become effective upon
- 18 its approval by the Governor or upon its becoming law without such approval.

19 SECTION 4.

20 All laws and parts of laws in conflict with this Act are repealed.
