- and of special note is the close cooperation between Major Woolard and the members of the
- 19 United States Marshal's Service and their Southeast Regional Fugitive Task Force; and

- 21 WHEREAS, his significant organizational and leadership talents, his remarkable patience
- and diplomacy, his keen sense of vision, and his sensitivity to the needs of the citizens of this
