A BILL TO BE ENTITLED AN ACT

- 1 To amend Chapter 5 of Title 12 of the Official Code of Georgia Annotated, relating to water
- 2 resources, so as to exempt permanent facility car washes and swimming pools from outdoor
- 3 water use restrictions under certain conditions; to provide an effective date; to repeal
- 4 conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6	SECTION 1.
7	Chapter 5 of Title 12 of the Official Code of Georgia Annotated, relating to water resources,
8	is amended in subsection (1) of Code Section 12-5-31, relating to permits for withdrawal,
9	diversion, or impoundment of surface waters generally and for farm uses and monitoring,
10	recording, and reporting water withdrawals, by deleting "and" at the end of paragraph (4) and
11	adding new paragraphs to read as follows:
12	"(4.1) The use of surface water by any permanent facility car wash shall be deemed not
13	to be outdoor water use for purposes of any outdoor watering restrictions if the facility:
14	(A) Is connected to a sanitary sewer system of a political subdivision or local
15	government authority or recycles used wash water; and
16	(B) Is certified by the division as meeting or exceeding applicable best management
17	practices for car washing facilities, which the Board of Natural Resources shall provide
18	by rules and regulations not later than October 1, 2008. Such certification shall expire
19	annually and may be issued or renewed upon compliance with such best management
20	practices and payment of a \$50.00 fee to the division. The provisions of this
21	subparagraph shall apply on and after the effective date of such board rules and
22	regulations;
23	(4.2) The use of surface water for any swimming pool shall be deemed not to be outdoor
24	water use for purposes of any outdoor watering restrictions if failure to maintain the
25	swimming pool would create unsafe, unsanitary, or unhealthy conditions, affecting the
26	public health or welfare; and "

SECTION 2.

2 Said chapter is further amended in Code Section 12-5-102, relating to emergency orders,

- 3 hearing, and appeal, by adding new subsections to read as follows:
- 4 "(e) The use of ground water by any permanent facility car wash shall be deemed not to
- 5 be outdoor water use for purposes of any outdoor watering restrictions if the facility:
- 6 (1) Is connected to a sanitary sewer system of a political subdivision or local government
- 7 authority or recycles used wash water; and
- 8 (2) Is certified by the division as meeting or exceeding applicable best management
- 9 practices for car washing facilities, which the Board of Natural Resources shall provide
- by rules and regulations not later than October 1, 2008. Such certification shall expire
- annually and may be issued or renewed upon compliance with such best management
- practices and payment of a \$50.00 fee to the division. The provisions of this paragraph
- shall apply on and after the effective date of such board rules and regulations.
- 14 (f) The use of ground water for any swimming pool shall be deemed not to be outdoor
- water use for purposes of any outdoor watering restrictions if failure to maintain the
- swimming pool would create unsafe, unsanitary, or unhealthy conditions, affecting the
- 17 public health or welfare."

SECTION 3.

- 19 This Act shall become effective upon its approval by the Governor or upon its becoming law
- 20 without such approval.

21 SECTION 4.

22 All laws and parts of laws in conflict with this Act are repealed.
