## A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating a new charter for the City of Kennesaw, approved April 10, 1971
- 2 (Ga. L. 1971, p. 3620), as amended, so as to change the provisions relating to the corporate
- 3 limits of the city; to repeal conflicting laws; and for other purposes.

## 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

5 SECTION 1.

- 6 An Act creating a new charter for the City of Kennesaw, approved April 10, 1971 (Ga. L.
- 7 1971, p. 3620), as amended, is amended by adding at the end of Section 1.02 the following:
- 8 "The corporate limits of the City of Kennesaw shall also include the following described
