A RESOLUTION

- 1 Urging the President and Congress of the United States to secure America's borders and
- 2 reject demands to repeat the failed 1986 legalization program for illegal aliens for the
- 3 protection of American jobs and our homeland; and for other purposes.
- 4 WHEREAS, President Barack Obama declared in his January 27, 2010, State of the Union
- 5 address that, "We should continue the work of fixing our broken immigration system to
- 6 secure our borders and enforce our laws, and ensure that everyone who plays by the rules can
- 7 contribute to our economy and enrich our nation"; and
- 8 WHEREAS, the President further declared on February 5, 2010, "We can't be satisfied when
- 9 another 20,000 have joined their ranks and millions more Americans are underemployed,
- 10 picking up what work they can"; and
- WHEREAS, the United States has proudly accepted more legal immigration than any other
- 12 nation in the world; and
- 13 WHEREAS, nearly 15 million Americans are currently without employment, and illegal
- 14 immigration takes jobs from Americans and lawfully present immigrants and places a heavy
- burden on the State of Georgia to provide federally mandated benefits and services to illegal
- 16 aliens; and
- 17 WHEREAS, states across the country face mounting difficulties in dealing with the rampant
- 18 unemployment of citizens and lawful workers who have waited in line, played by the rules,
- 19 and legally joined the American family; and
- 20 WHEREAS, legalizing illegal immigrants who escaped capture while crossing American
- 21 borders is contrary to the basic principals of fairness and justice upon which this great
- 22 country was founded; and

WHEREAS, federal legislation in 1986 which legalized approximately 3 million illegal

- 24 aliens served only to reward illegal activity and to encourage further illegal immigration; and
- 25 WHEREAS, estimates of the number of illegal aliens currently present in the United States
- are between 11 million and 20 million; and
- 27 WHEREAS, estimates of the number of illegal aliens in Georgia are between 450,000 and
- 28 1 million; and
- 29 WHEREAS, the State of Georgia is unable to withstand the financial burden created by
- 30 illegal immigration; and
- 31 WHEREAS, illegal immigration threatens the security and public safety of all Georgians;
- 32 and
- 33 WHEREAS, illegal immigration negatively impacts all aspects of the State of Georgia,
- 34 including the economy, social services, education services, the criminal justice system, and
- 35 health care services; and
- 36 WHEREAS, Georgia's budget cannot withstand the added burden of benefits for which
- 37 presently illegal aliens would become eligible with the removal of illegal immigration status;
- 38 and
- 39 WHEREAS, an illegal labor market, fraudulent documents, and uncontrolled borders
- 40 undermine our national security; and
- 41 WHEREAS, enforcement of American immigration laws has proven to be the real solution
- 42 to encouraging illegal aliens to migrate out of the United States and Georgia and to reduce
- 43 further illegal immigration; and
- 44 WHEREAS, immigration reform must reflect and serve the interests and needs of the
- 45 American people by addressing the national issues of homeland security and the economy;
- 46 and
- 47 WHEREAS, any future immigration reform therefore must reject amnesty and be founded
- 48 on the principals of enforcement and border security; and

49 WHEREAS, it is the right and duty of each state to defend and protect its citizens from the

- 50 dangers and costs resulting from lack of border security and absence of strict immigration
- 51 law enforcement by the federal government; and
- 52 WHEREAS, this body should enthusiastically encourage the adoption of laws which enforce
- 53 federal immigration requirements.
- 54 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 55 the members of this body urge the President and Congress of the United States to secure
- 56 America's borders and reject demands to repeat the failed 1986 legalization program for
- 57 illegal aliens for the protection of American jobs and our homeland.
- 58 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
- and directed to transmit an appropriate copy of this resolution to each member of the Georgia
- 60 congressional delegation and the President of the United States.
