A RESOLUTION

- 1 Recognizing the growing incidence of chronic obstructive pulmonary disease in this state and
- 2 encouraging the Georgia Department of Community Health to pass regulations requiring the
- 3 collection of data relating to incidents of this disease in this state; and for other purposes.
- 4 WHEREAS, it is estimated that 16 million people in the United States are diagnosed with
- 5 chronic obstructive pulmonary disease (COPD), equal to one in 19 Americans; and
- 6 WHEREAS, COPD is a progressive disease that includes emphysema and chronic bronchitis,
- 7 alone or in combination; and
- 8 WHEREAS, the prevalence of COPD has almost doubled over the last 25 years, and it stands
- 9 as the only major disease with an increasing death rate; and
- 10 WHEREAS, COPD accounted for 1.5 million emergency room visits in 2000 and is the
- 11 fourth leading cause of death in the United States, accounting for 127,000 deaths in 2004;
- 12 and
- 13 WHEREAS, COPD can be controlled and its progression slowed with proper treatment; and
- 14 WHEREAS, the Georgia Department of Community Health currently collects public health
- data relating to the incidence of other diseases but does not currently collect public health
- data relating to the prevalence of COPD in the State of Georgia; and
- 17 WHEREAS, this state's public health organization bears a responsibility in identifying the
- burden that COPD places on its citizens and on the health care system and in insuring that
- 19 appropriate and effective treatments are available; and
- 20 WHEREAS, accurate data on incidents of COPD in Georgia should be used to monitor the
- 21 frequency, incidence, cause, effect, and severity of COPD; and

22 WHEREAS, COPD data should be used to assist the department in research and the

- 23 evaluation of disease management practices in order to assess the current standard of care for
- 24 COPD patients; and
- 25 WHEREAS, annual data on COPD should be reported to the Governor by the Department
- of Community Health, along with recommendations for improving treatment options for
- 27 citizens with COPD.
- 28 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 29 the members of this body encourage the Georgia Department of Community Health to pass
- 30 regulations requiring the collection of data relating to chronic obstructive pulmonary disease,
- 31 along with the collection of data on other diseases and conditions in this state.
- 32 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
- and directed to transmit an appropriate copy of this resolution to members of the public and
- 34 the press.
