## A RESOLUTION

- Directing the Professional Standards Commission to temporarily modify its rules relating to 1
- 2 professional learning requirements for certificate renewal and creating the Certification and
- 3 Professional Learning Task Force; and for other purposes.

4 WHEREAS, local school systems are facing shrinking resources and Georgia educators are

5 experiencing furloughs and other financial setbacks; and

6 WHEREAS, professional learning activities for educators cost money to both educators and 7 local school systems; and

8 WHEREAS, temporarily reducing professional learning requirements for clear renewable

9 certificate renewal may save both local school systems and individual educators money and

10 provide them with additional flexibility; and

11 WHEREAS, this is an era of substantive change in education, with new initiatives related to

12 the federal Race to the Top fund, the impending reauthorization of the Elementary and

13 Secondary Education Act, increased flexibility for schools, charter schools, raising

14 achievement in underachieving schools, and similar efforts; and

15 WHEREAS, this changing environment and the temporary modification of Professional 16 Standards Commission rules for professional learning requirements for clear renewable 17 certificates provide an opportunity to analyze and restructure professional development 18 requirements.

19 NOW, THEREFORE, BE IT RESOLVED AND ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA: 20

## **SECTION 1.**

Between July 1, 2010, and July 1, 2015, the Professional Standards Commission shall 22 23 temporarily modify its rules relating to professional learning requirements for certificate 24 renewal for clear renewable certificates so that educators whose clear renewable certificates 25 require renewal during such period shall be required to complete no more than five

26 professional learning units or their equivalent to meet the professional learning renewal

27 requirements.

**SECTION 2.** 

- 29 (a) There is created the Certification and Professional Learning Task Force for the purposes
- 30 of reviewing certificate renewal requirements and procedures and making recommendations
- 31 for improvement with the goal of improving schools and teaching, leading to improved
- 32 student learning.
- 33 (b) The task force shall consist of 16 members as follows:
- 34 (1) Two representatives from the Professional Standards Commission, as designated by
- 35 the executive secretary of the commission;
- 36 (2) Two representatives from the Department of Education, as designated by the State
  37 Superintendent of Schools;
- 38 (3) One representative from the central office of the University System of Georgia, as39 designated by the chancellor;
- 40 (4) One representative from a college of education within the University System of
- 41 Georgia, as designated by the chancellor;
- 42 (5) One representative from a private Georgia college of education, appointed by the43 President of the Senate;
- 44 (6) One representative local school system professional learning coordinator, appointed
- 45 by the Speaker of the House of Representatives;
- 46 (7) One representative from a regional educational service agency, appointed by the47 President of the Senate;
- 48 (8) One representative local school superintendent, appointed by the Speaker of the House
- 49 of Representatives;
- 50 (9) One representative public school principal, appointed by the President of the Senate;
- 51 (10) One representative public elementary school teacher, appointed by the Speaker of the
- 52 House of Representatives;
- (11) One representative public middle school teacher, appointed by the President of theSenate;
- (12) One representative public high school teacher, appointed by the Speaker of the House
  of Representatives;
- 57 (13) One representative from the Georgia Staff Development Council, as designated by58 the council; and
- 59 (14) One representative from the Governor's Office of Planning and Budget, as designated
- 60 by the Governor.

- 61 (c) The task force shall be chaired by a representative from the Professional Standards
- 62 Commission. The task force shall meet at the call of the chairperson. Members of the task
- 63 force shall serve without compensation.
- 64 (d) The task force shall study and make recommendations on:
- 65 (1) The roles of state agencies, local school systems, regional educational service agencies,
- 66 colleges and universities, and other organizations in providing high quality professional
- learning focused on improving schools and teaching, resulting in improved studentlearning;
- 69 (2) The effectiveness of current professional learning renewal requirements on school
- 70 improvement and student learning; and
- 71 (3) The adequacy of the current professional learning activities delivery system.
- 72 (e) The task force shall present an interim report to the chairpersons of the House Committee
- on Education and the Senate Education and Youth Committee by April 15, 2011, with a final
- report of its findings and recommendations to be completed no later than November, 2011.
- 75 The report shall be presented to a joint session of the House Committee on Education and the
- 76 Senate Education and Youth Committee no later than November 30, 2011. The task force
- shall stand abolished on November 30, 2011.
