## A RESOLUTION

- 1 Honoring the life and memory of Mr. Michael A. "Mickey" Wilson; and for other purposes.

3 with the passing of Mr. Michael A. "Mickey" Wilson on February 26, 2010; and
- 4 WHEREAS, Mr. Wilson was born on June 14, 1936, in New Holland, Georgia, a beloved

- 6 WHEREAS, a life-long resident of Hall County, Mr. Wilson graduated from Georgia  
7 Southern University, the University of Georgia School of Banking, and Louisiana State  
8 University School of Banking, and was a respected community banker for many years; and

10 Miller Wilson, and was blessed with the love and support of his children, Drew and Dane  
11 Rowe Wilson and Mitch and Anslee Dunckel Wilson, and five remarkable grandchildren,

- 13 WHEREAS, a strong supporter of community and civic organizations, Mr. Wilson was a  
14 member of the Traditional Bowhunters of Georgia, a life member of the Gainesville Elks  
15 Lodge and the Chattahoochee Country Club, and assisted the Hall County 4-H Youth  
16 Archery Program; and
- 17 WHEREAS, he gave inspiration to many through his high ideals, morals, and deep concern  
18 for his fellow citizens, and the devotion, patience, and understanding he demonstrated to his  
19 family and friends were admired by others; and
- 20 WHEREAS, he was a person of magnanimous strengths with an unimpeachable reputation  
21 for integrity, intelligence, fairness, and kindness and, by the example he made of his life, he  
22 made this world a better place in which to live; and

23 WHEREAS, a compassionate and generous man, Mr. Wilson will long be remembered for  
24 his love of the outdoors, family, and friendship, and this loyal husband, brother, father,  
25 grandfather, and friend will be missed by all who had the great fortune of knowing him.
