

Senate Bill 479

A BILL TO BE ENTITLED  
AN ACT

1 To amend Article 2 of Chapter 5 of Title 36 of the Official Code of Georgia Annotated,  
2 relating to county governing authorities, so as to authorize county governing authorities to  
3 reapportion election districts for county governing authorities; to provide for procedures,  
4 conditions, and limitations; to provide an effective date; to repeal conflicting laws; and for  
5 other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 Article 2 of Chapter 5 of Title 36 of the Official Code of Georgia Annotated, relating to  
9 county governing authorities, is amended by adding a new Code section to read as follows:  
10 "36-5-30.

11 (a) Subject to the limitations provided in this Code section, the governing authority of any  
12 county shall be authorized to reapportion the election districts from which members of such  
13 county governing authority are elected. Such reapportionment of districts shall be effective  
14 for the election of members to the county governing authority at the next regular general  
15 county election following adoption of the reapportionment ordinance.

16 (b) A county governing authority may reapportion election districts by an ordinance duly  
17 adopted at a meeting of such governing authority following two public hearings not less  
18 than seven nor more than 60 days apart. The second hearing shall be held no more than ten  
19 days prior to the meeting at which final action is taken. A notice containing a synopsis of  
20 the proposal shall be published in the official organ of the county or in a newspaper of  
21 general circulation in the county once a week for three weeks within a period of 60 days  
22 immediately preceding its final adoption. The notice shall state that a copy of the proposed  
23 ordinance reapportioning county election districts is on file in the office of the clerk of the  
24 county governing authority for the purpose of examination and inspection by the public.  
25 The clerk shall furnish any person, upon written request, with a copy of the proposed  
26 ordinance.

27 (c) Reapportionment of county election districts authorized by this Code section shall be  
 28 in accordance with the following specifications:

29 (1) Each reapportionment district shall be formed of contiguous territory, and the  
 30 boundary lines of each district shall be the center lines of streets or other well-defined  
 31 boundaries;

32 (2) Variations in population among such districts shall comply with the one person, one  
 33 vote requirements of the United States Constitution; and

34 (3) Reapportionment shall be limited to adjusting the boundary lines of existing districts  
 35 only to the extent reasonably necessary to comply with the requirements of paragraph (2)  
 36 of this subsection and federal law.

37 (d) In exercising its powers pursuant to this Code section, a county governing authority  
 38 shall not be authorized to change the number of members of such county governing  
 39 authority or the manner of electing such members.

40 (e) Following adoption of a reapportionment ordinance, the county shall submit the  
 41 ordinance for preclearance pursuant to the federal Voting Rights Act of 1965, as amended.  
 42 Following such preclearance, a copy of the ordinance reapportioning election districts shall  
 43 be filed with the Secretary of State and in the office of the clerk of the superior court of the  
 44 county whose election districts were reapportioned pursuant to this Code section.

45 (f) This Code section shall not prohibit the General Assembly from enacting a local law  
 46 to reapportion or otherwise change election districts from which members of a county  
 47 governing authority are elected. If such action is taken by the General Assembly following  
 48 publication of a decennial census, but before the first regular general county election  
 49 following the publication of such census, the local Act of the General Assembly shall  
 50 nullify the power given to the county governing authority by subsections (a) through (e)  
 51 of this Code section."

52 **SECTION 2.**

53 This Act shall become effective upon its approval by the Governor or upon its becoming law  
 54 without such approval.

55 **SECTION 3.**

56 All laws and parts of laws in conflict with this Act are repealed.
