A BILL TO BE ENTITLED  
AN ACT

1 To amend Code Section 50-14-1 of the Official Code of Georgia Annotated, relating to open  
2 and public meetings, so as to change posting and advertisement requirements for all meetings  
3 of county boards of tax assessors; to repeal conflicting laws; and for other purposes.

4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

5 style="text-align:center">**SECTION 1.**

6 Code Section 50-14-1 of the Official Code of Georgia Annotated, relating to open and public  
7 meetings, is amended by revising subsection (d) and adding a new subsection to read as  
8 follows:

9 "(d)(1) This subsection shall apply to all agency meetings except as otherwise provided  
10 in subsection (d.1) of this Code section.

11 (2) Every agency shall prescribe the time, place, and dates of regular meetings of the  
12 agency. Such information shall be available to the general public and a notice containing  
13 such information shall be posted and maintained in a conspicuous place available to the  
14 public at the regular meeting place of the agency. Meetings shall be held in accordance  
15 with a regular schedule, but nothing in this subsection shall preclude an agency from  
16 canceling or postponing any regularly scheduled meeting. Whenever any meeting  
17 required to be open to the public is to be held at a time or place other than at the time and  
18 place prescribed for regular meetings, the agency shall give due notice thereof. 'Due  
19 notice' shall be the posting of a written notice for at least 24 hours at the place of regular  
20 meetings and giving of written or oral notice at least 24 hours in advance of the meeting  
21 to the legal organ in which notices of sheriff's sales are published in the county where  
22 regular meetings are held or at the option of the agency to a newspaper having a general  
23 circulation in said county at least equal to that of the legal organ; provided, however, that  
24 in counties where the legal organ is published less often than four times weekly 'due  
25 notice' shall be the posting of a written notice for at least 24 hours at the place of regular  
26 meetings and, upon written request from any local broadcast or print media outlet whose

27 place of business and physical facilities are located in the county, notice by telephone or  
 28 facsimile to that requesting media outlet at least 24 hours in advance of the called  
 29 meeting. When special circumstances occur and are so declared by an agency, that  
 30 agency may hold a meeting with less than 24 hours' notice upon giving such notice of the  
 31 meeting and subjects expected to be considered at the meeting as is reasonable under the  
 32 circumstances including notice to said county legal organ or a newspaper having a  
 33 general circulation in the county at least equal to that of the legal organ, in which event  
 34 the reason for holding the meeting within 24 hours and the nature of the notice shall be  
 35 recorded in the minutes. Whenever notice is given to a legal organ or other newspaper,  
 36 that publication shall immediately make the information available upon inquiry to any  
 37 member of the public. Any oral notice required or permitted by this subsection may be  
 38 given by telephone.

39 (d.1) Every county board of tax assessors shall prescribe the time, place, and dates of  
 40 regular meetings of the county board of tax assessors. Meetings shall be held in  
 41 accordance with a regular schedule, but nothing in this subsection shall preclude an agency  
 42 from canceling or postponing any regularly scheduled meeting. Whenever any regular  
 43 meeting of a county board of tax assessors is to be held or whenever any meeting required  
 44 to be open to the public is to be held at a time or place other than at the time and place  
 45 prescribed for regular meetings, the county board of tax assessors shall give due notice  
 46 thereof. 'Due notice' shall be the posting of a written notice for at least one week at the  
 47 place of regular meetings and giving of written or oral notice at least one week in advance  
 48 of the meeting to the legal organ in which notices of sheriff's sales are published in the  
 49 county where regular meetings are held or at the option of the agency to a newspaper  
 50 having a general circulation in said county at least equal to that of the legal organ. When  
 51 special circumstances occur and are so declared by a county board of tax assessors, that  
 52 county board of tax assessors may hold a meeting with less than one weeks' notice upon  
 53 giving such notice of the meeting and subjects expected to be considered at the meeting as  
 54 is reasonable under the circumstances including notice to said county legal organ or a  
 55 newspaper having a general circulation in the county at least equal to that of the legal  
 56 organ, in which event the reason for holding the meeting within less than one weeks' time  
 57 and the nature of the notice shall be recorded in the minutes. Whenever notice is given to  
 58 a legal organ or other newspaper, that publication shall immediately make the information  
 59 available upon inquiry to any member of the public. Any oral notice required or permitted  
 60 by this subsection may be given by telephone."

61 **SECTION 2.**

62 All laws and parts of laws in conflict with this Act are repealed.
