A BILL TO BE ENTITLED
AN ACT

1 To amend Chapter 8 of Title 50 of the Official Code of Georgia Annotated, relating to the
2 Department of Community Affairs, so as to create the Martin Luther King, Jr. Advisory
3 Council; to provide for membership on the commission; to provide for terms and duties of
4 members; to provide for an annual report; to provide for related matters; to provide for an
5 effective date; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 Chapter 8 of Title 50 of the Official Code of Georgia Annotated, relating to the Department
9 of Community Affairs, is amended by adding a new article to read as follows:

10 "ARTICLE 10

11 50-8-240.

12 (a) There is created within the Department of Community Affairs the Martin Luther King,
13 Jr. Advisory Council.

14 (b) The council shall consist of nine members as follows:

15 (1) The commissioner of community affairs or his or her designee;

16 (2) Six members to be appointed by the Governor, two of whom shall be between the
17 ages of 18 and 22 years;

18 (3) One member to be appointed by the President of the Senate; and

19 (4) One member to be appointed by the Speaker of the House of Representatives.

20 (c) Members shall serve four year terms. No member of the commission shall serve more
21 than two consecutive terms.

22 (d) Vacancies in the membership of the commission shall be filled for the balance of the
23 unexpired term by the appointing authority.

24 (e) The council shall select annually a chairperson from among its membership.

25 (f) Members of the council shall be subject to removal from office by the appointing
 26 authority when the actions or condition of a member shall be considered as good cause for
 27 removal.

28 (g) A majority of the council shall constitute a quorum for the transaction of business.

29 (h) Members of the council shall serve without compensation but, to the extent moneys are
 30 appropriated therefor, shall be eligible to receive reimbursement for mileage and other
 31 expenses actually incurred in performance of their duties in accordance with the rates and
 32 standards for reimbursement of state employees.

34 The Martin Luther King, Jr. Advisory Council shall have the following duties:

35 (1) To promote racial harmony, understanding, respect, and good will among all citizens;

36 (2) To promote principles of nonviolence, peace, and social justice;

37 (3) To promote among the people of Georgia, by appropriate activities, both awareness
 38 and appreciation of the Civil Rights movement and advocacy of the principles and legacy
 39 of Martin Luther King, Jr.;

40 (4) To develop, coordinate, and advise the state of appropriate ceremonies and activities
 41 relating to the observance of the birthday of Martin Luther King, Jr., including, without
 42 limitation, providing advice and assistance to local governments and private
 43 organizations with respect to the observance of the birthday of Martin Luther King, Jr.;

44 (5) To enable the people of Georgia to reflect on the life and teachings of Martin Luther
 45 King, Jr., through educational endeavors, cultural performances, exhibitions, and events
 46 that are multiethnic and family oriented; and

47 (6) To prepare an annual report for the Governor and the General Assembly detailing the
 48 actions taken to fulfill these responsibilities and duties.

50 (a) To the extent moneys are appropriated therefor, the council may employ staff and
 51 consultants and fix their compensation, duties, authority, and responsibilities.

52 (b) The council is assigned to the Department of Community Affairs for administrative
 53 purposes."

54 **SECTION 2.**

55 This Act shall become effective upon its approval by the Governor or upon its becoming law
 56 without such approval.

SECTION 3.

58 All laws and parts of laws in conflict with this Act are repealed.
