A RESOLUTION

- 1 Honoring the life and memory of Mr. Louis John Fortuna; and for other purposes.
- 2 WHEREAS, the State of Georgia mourns the loss of one of its most distinguished citizens
3 with the passing of Mr. Louis John Fortuna on May 19, 2008; and
- 4 WHEREAS, Mr. Fortuna was born on January 19, 1917, in Manchester, New Hampshire,
5 and was affectionately known as "Pop" to family and friends; and
- 6 WHEREAS, he served as a guardian of this nation's freedom and liberty with the United
7 States Navy from 1942 to 1946 and with the United States Naval Reserve for 20 years, where
8 he retired as commander; and
- 9 WHEREAS, Mr. Fortuna earned a bachelor's degree from Dartmouth College, where he was
10 a member of the Delta Upsilon fraternity, graduated from Georgetown Law School, and
11 served as a recruiter for Dartmouth College for a number of years; and
- 12 WHEREAS, a banker who loved his profession, Mr. Fortuna was an employee of C&S
13 National Bank from 1948 to 1972, where he retired as president of the Nations Bank of
14 Sandy Springs, was a co-founder of the Consumer Credit Counseling Service, and taught
15 classes at the University of Georgia School of Banking; and
- 16 WHEREAS, Mr. Fortuna was united in love and marriage for 59 wonderful years to the late
17 Louise Harman Fortuna, and was blessed with the love of his children, Kenneth Fortuna,
18 Lucile and Don Carter, Don and Genevieve Fortuna, and Lee and David Glover, and
19 numerous grandchildren; and
- 20 WHEREAS, he and his wife were active members of Glenn Memorial United Methodist
21 Church and the couples class for many years and he was an active member of First United
22 Methodist Church in Gainesville; and

23 WHEREAS, he gave inspiration to many through his high ideals, morals, and deep concern
24 for his fellow citizens, and the devotion, patience, and understanding he demonstrated to his
25 family and friends were admired by others; and

26 WHEREAS, he was a person of magnanimous strengths with an unimpeachable reputation
27 for integrity, intelligence, fairness, and kindness and, by the example he made of his life, he
28 made this world a better place in which to live; and

29 WHEREAS, a compassionate and generous man, Mr. Fortuna will long be remembered for
30 his love of family and friendship, and this loyal brother, father, grandfather, and friend will
31 be missed by all who had the great fortune of knowing him.
