

The House Committee on Judiciary Non-civil offers the following substitute to SB 299:

A BILL TO BE ENTITLED  
AN ACT

1 To amend Part 7 of Article 1 of Chapter 11 of Title 15 of the Official Code of Georgia  
2 Annotated, relating to delinquent and unruly children, so as to change provisions relating to  
3 the zero tolerance policy on weapons in schools; to change provisions relating to the  
4 designated felony act; to amend Code Section 16-11-127.1 of the Official Code of Georgia  
5 Annotated, relating to carrying weapons within school safety zones, at school functions, or  
6 on school property, so as to change a provision relating to handling cases involving children;  
7 to provide for related matters; to provide for an effective date; to repeal conflicting laws; and  
8 for other purposes.

9 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

10 SECTION 1.

11 Part 7 of Article 1 of Chapter 11 of Title 15 of the Official Code of Georgia Annotated,  
12 relating to delinquent and unruly children, is amended by revising paragraph (2) of  
13 subsection (a) of Code Section 15-11-63, relating to designated felony acts, as follows:

14 "(2) 'Designated felony act' means an act which:

15 (A) Constitutes a second or subsequent offense under subsection (b) of Code Section  
16 16-11-132 if committed by a child 13 to 17 years of age;

17 (B) If done by an adult, would be one or more of the following crimes:

18 (i) Kidnapping or arson in the first degree, if done by a child 13 or more years of age;

19 (ii) Aggravated assault, arson in the second degree, aggravated battery, robbery,  
20 armed robbery not involving a firearm, or battery in violation of Code Section  
21 16-5-23.1 if the victim is a teacher or other school personnel, if done by a child 13 or  
22 more years of age;

23 (iii) Attempted murder or attempted kidnapping, if done by a child 13 or more years  
24 of age;

25 (iv) ~~The carrying or possession of a weapon in violation of subsection (b) of Code~~  
26 ~~Section 16-11-127.1~~ Reserved;

- 27 (v) Hijacking a motor vehicle, if done by a child 13 or more years of age;
- 28 (vi) Any violation of Code Section 16-7-82, 16-7-84, or 16-7-86 if done by a child  
29 13 or more years of age;
- 30 (vii) Any other act which, if done by an adult, would be a felony, if the child  
31 committing the act has three times previously been adjudicated delinquent for acts  
32 which, if done by an adult, would have been felonies;
- 33 (viii) Any violation of Code Section 16-13-31, relating to trafficking in cocaine,  
34 illegal drugs, marijuana, or methamphetamine;
- 35 (ix) Any criminal violation of Code Section 16-14-4, relating to racketeering; or
- 36 (x) Any violation of Code Section 16-10-52, relating to escape, if the child involved  
37 in the commission of such act has been previously adjudicated to have committed a  
38 designated felony;
- 39 (C) Constitutes a second or subsequent adjudication of delinquency based upon a  
40 violation of Code Section 16-7-85 or 16-7-87;
- 41 (C.1) Constitutes any violation of Code Section 16-15-4, relating to criminal street  
42 gangs;
- 43 (C.2) Constitutes a second or subsequent adjudication of delinquency based on a  
44 violation of Code Section 16-11-127.1 or is a first violation of Code Section  
45 16-11-127.1 involving:
- 46 (i) Any weapon, as such term is defined in Code Section 16-11-127.1, together with  
47 an assault;
- 48 (ii) A firearm as defined in paragraph (2) of subsection (a) of Code Section  
49 16-11-131; or
- 50 (iii) A dangerous weapon or machine gun as defined in Code Section 16-11-121;
- 51 (D) Constitutes an offense within the exclusive jurisdiction of the superior court  
52 pursuant to subparagraph (b)(2)(A) of Code Section 15-11-28 which is transferred by  
53 the superior court to the juvenile court for adjudication pursuant to subparagraph  
54 (b)(2)(B) of Code Section 15-11-28 or which is transferred by the district attorney to  
55 the juvenile court for adjudication pursuant to subparagraph (b)(2)(C) of Code Section  
56 15-11-28; or
- 57 (E) Constitutes a second or subsequent violation of Code Sections 16-8-2 through  
58 16-8-9, relating to theft, if the property which was the subject of the theft was a motor  
59 vehicle."

**SECTION 2.**

61 Code Section 16-11-127.1 of the Official Code of Georgia Annotated, relating to carrying  
62 weapons within school safety zones, at school functions, or on school property, is amended  
63 by revising subsection (b) as follows:

64 "(b) Except as otherwise provided in subsection (c) of this Code section, it shall be  
65 unlawful for any person to carry to or to possess or have under such person's control while  
66 within a school safety zone or at a school building, school function, or school property or  
67 on a bus or other transportation furnished by the school any weapon or explosive  
68 compound, other than fireworks the possession of which is regulated by Chapter 10 of Title  
69 25. Any person who violates this subsection shall be guilty of a felony and, upon  
70 conviction thereof, be punished by a fine of not more than \$10,000.00, by imprisonment  
71 for not less than two nor more than ten years, or both; provided, however, that upon  
72 conviction of a violation of this subsection involving a firearm as defined in paragraph (2)  
73 of subsection (a) of Code Section 16-11-131, or a dangerous weapon or machine gun as  
74 defined in Code Section 16-11-121, such person shall be punished by a fine of not more  
75 than \$10,000.00 or by imprisonment for a period of not less than five nor more than ten  
76 years, or both. A child who violates this subsection ~~shall~~ may be subject to the provisions  
77 of Code Section 15-11-63."

**SECTION 3.**

79 This Act shall become effective upon its approval by the Governor or upon its becoming law  
80 without such approval.

**SECTION 4.**

82 All laws and parts of laws in conflict with this Act are repealed.
