### A RESOLUTION

1 Recognizing and commending Reverend Dr. Tom Stephenson on the occasion of his  
2 retirement from Central Christian Church; and for other purposes.

3 WHEREAS, Reverend Dr. Tom Stephenson has demonstrated his commitment to teaching  
4 the Gospel, witnessing Christ through word and deed, and addressing the physical,  
5 psychological, intellectual, and spiritual needs of others; and

6 WHEREAS, Reverend Stephenson was called by the Lord 17 years ago to lead the  
7 congregation of Central Christian Church in Columbus, Georgia; and

19 troubled, baptizing a new believer, or acting as a theologian, educator, administrator, or  
20 humanitarian, Reverend Stephenson serves as a shining example of God's righteous path; and

21 WHEREAS, Reverend Stephenson has been united in love and marriage to his supportive  
22 wife, Gladys, for 25 wonderful years and they have been blessed with two remarkable sons,  
23 Jesse and Sam; and

24 WHEREAS, the unmatched spiritual assistance offered by Reverend Stephenson is a source  
25 of strength and direction for persons in all walks of life and from all economic strata; and

26 WHEREAS, although his daily presence will be sorely missed upon the occasion of his  
27 retirement as pastor, Reverend Stephenson's influence is sure to be felt for many years to  
28 come.
