A BILL TO BE ENTITLED AN ACT

- 3 14, 1997 (Ga. L. 1997, p. 4189), and an Act approved April 19, 2000 (Ga. L. 2000, p. 4210),
- 4 so as to create the office of county manager; to prescribe powers and duties; to provide that
- 5 the chairperson of the Pierce County Board of Commissioners shall serve on a part-time
- 6 basis; to provide for a salary; to provide for related matters; to repeal conflicting laws; and
- 7 for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 SECTION 1.

- 10 An Act incorporating the Board of Commissioners of Pierce County, approved March 24,
- 11 1937 (Ga. L. 1937, p. 1397), as amended, particularly by an Act approved April 14, 1997
- 12 (Ga. L. 1997, p. 4189), and an Act approved April 19, 2000 (Ga. L. 2000, p. 4210), is
- 13 amended by revising Section 7 as follows:
- 14 "SECTION 7.
- 15 The chairperson of the board of commissioners shall serve on a part-time basis and shall
- receive a salary in the amount of \$18,000.00."
- 17 SECTION 2.
- 18 Said Act is further amended by revising Section 13 as follows:
- 19 "SECTION 13.
- 20 (a) Pursuant to Code Section 36-5-22 of the O.C.G.A., there is created the office of county
- 21 manager for Pierce County. The county manager shall be the chief administrative officer
- and head of the administrative branch of the county government. The county manager shall
- be responsible for the efficient administration of all county departments.

24 (b) The county manager shall be appointed by a majority vote of the board of

- 25 commissioners of Pierce County who shall determine and prescribe his or her
- 26 compensation and term of office. Said board of commissioners may contract with the
- county manager on such terms as it may deem reasonable and prudent. No member of the
- board of commissioners shall be appointed county manager on either a permanent or
- interim basis during the term of office for which he or she is elected or for a period of one
- year after terminating his or her office as a commissioner of Pierce County.
- 31 (c) The county manager shall devote all of his or her working time and attention to the
- 32 affairs of the county and shall be responsible to the board of commissioners for the efficient
- administration of all of the affairs of the county over which the county manager has
- jurisdiction. The powers and duties of the county manager shall be:
- 35 (1) To see that all laws, county codes, and ordinances are enforced;
- 36 (2) To appoint all department heads with the approval of the board of commissioners;
- 37 (3) To appoint and remove all subordinate officers and employees in all departments;
- 38 (4) To exercise control over all departments and divisions created therein or which may
- 39 hereafter be created by the board of commissioners;
- 40 (5) To attend all meetings of the board of commissioners with the right to take part in all
- 41 discussions but having no vote;
- 42 (6) To recommend to the board of commissioners such measures for adoption which he
- or she may deem necessary and expedient;
- 44 (7) To prepare and submit to the board of commissioners an annual budget;
- 45 (8) To keep the board of commissioners fully advised as to the financial condition and
- 46 needs of the county;
- 47 (9) To supervise and direct the official conduct of all county officers and employees
- except as otherwise provided in this Act;
- 49 (10) To supervise the performance of all contracts made by any person for work done for
- 50 the county, to make all purchases of materials and supplies for the county, and to see that
- 51 the same are received as contracted for; and
- 52 (11) To perform such other duties as may be prescribed in this Act or required of the
- county manager by ordinance or resolution of the board of commissioners.
- 54 (d) In the event of a vacancy in the office of county manager, the board of commissioners
- shall expeditiously proceed with due diligence to appoint an interim county manager. In
- no such event shall the board of commissioners allow the office of county manager to
- 57 remain vacant for a period in excess of four weeks from the date said office became vacant.
- 58 Specifically, the board of commissioners shall, at the least, fill any vacancy in the office
- of county manager with an interim county manager within four weeks from the date of
- vacancy. Furthermore, the board of commissioners shall advertise for the permanent

position of county manager at the first opportunity upon vacancy of the office of county
